Rough path properties for local time of symmetric α stable process

Abstract

In this paper, we first prove that the local time associated with symmetric α -stable processes is of bounded p-variation for any $p>\frac{2}{\alpha-1}$ partly based on Barlow's estimation of the modulus of the local time of such processes. The fact that the local time is of bounded p-variation for any $p>\frac{2}{\alpha-1}$ enables us to define the integral of the local time $\int_{-\infty}^{\infty} \nabla_{-}^{\alpha-1} f(x) d_x L_x^t$ as a Young integral for less smooth functions being of bounded q-variation with $1 \leq q < \frac{2}{3-\alpha}$. When $q \geq \frac{2}{3-\alpha}$, Young's integration theory is no longer applicable. However, rough path theory is useful in this case. The main purpose of this paper is to establish a rough path theory for the integration with respect to the local times of symmetric α -stable processes for $\frac{2}{3-\alpha} \leq q < 4$.

Key words: Young integral, rough path, local time, p-variation, α -stable processes, Itô's formula

1. Introduction

Itô [15] developed the integration theory with respect to Brownian motion and the chain rule for Brownian motion known as Itô's formula. We first recall Itô's formula developed in 1944 as follows.

(Itô's Theorem (1944)) Let $f: \mathbb{R} \to \mathbb{R}$ be a function of the class C^2 and $B = \{B_t, \mathcal{F}_t : 0 \le t < \infty\}$ be any Brownian motion on (Ω, \mathcal{F}_t) , then

$$f(B_t) = f(B_0) + \int_0^t f'(B_s)dB_s + \frac{1}{2} \int_0^t f''(B_s)ds.$$

For Itô's formula, the contribution lies in defining the stochastic integral $\int f'(B_s)dB_s$. An integral $\int XdZ$ can be defined as a Stieltjes integral pathwise when the integrator Z is of finite variation and the integrand X is continuous. However, Brownian motion is not of bounded variation a.s. and when the integrator is of infinite variation, there did not exist an integration theory in place to use before Itô dealt with this issue.

Despite a huge success, Itô's original formula has its own limitations as it applies for Brownian motion and for functions with twice differentiability only. This hinders the applicability of Itô's formula. On one hand, one often encounters the need to define the stochastic integral for a wide class of stochastic processes besides Brownian motion. Doob [10] emphasized the martingale property of Itô's integral. Subsequently, Doob proposed a general martingale integral after discovering the key role of the martingale property of Brownian motion in defining Itô's integral. In order to build the theory, he needed to decompose the square of an L^2 -martigale. This was done latter in [28]. Based on [28], Kunita and Watanabe in [17] defined an integral provided the integrand is previsible for the case the integrator is a square integrable martingale. They generalized Itô's formula to continuous martingales only and proved the above Itô's formula is still valid if ds is replaced by $d < X >_s$ (see Section 2, [17]) and generalized Itô's formula to discontinuous martingales (see section 5, [17]). Meanwhile, Meyer [29] extended Itô's formula to local martingales of which the concept was introduced in [16]. Meyer [30] further extended Itô's formula to semimartingales.

On the other hand, one also encounters the restriction of using Itô's formula in the cases when the function is not C^2 in the space variable. The first result in this direction is the Itô-Tanaka's formula derived in [34] for f(x) = |x| with the help of the local time. The concept of local time was first introduced in Lévy [19]. It has been indeed the wellspring of much of the extensions of Itô's formula for functions not being C^2 in the space variable. Wang [35] extended Itô's formula to a time independent convex function which is being absolutely continuous with its first order derivative being of bounded variation. Bouleau and Yor [8] made a further extension to absolutely continuous functions with locally bounded first order derivative. The idea to extend Itô's formula to less smooth functions of Feng and Zhao in their papers [12, 13, 14] is to establish a Young's integration theory and a rough path integration theory for local time. Young [37] showed that the pathwise integral $\int X dZ$ makes sense if X is of finite p-variation and Z is of finite q-variation where $\frac{1}{p} + \frac{1}{q} > 1$, together with the condition that X and Z have no common discontinuities. The theory of rough paths was developed by Lyons and his co-authors in a series of papers (see, e.g. [5, 9, 20, 21, 22, 23, 24]). Rough path theory removed the restriction of $\frac{1}{p} + \frac{1}{q} > 1$, hence applicable to even rougher paths.

The purpose of this paper is to establish the integral $\int_{-\infty}^{\infty} \nabla_{-}^{\alpha-1} f(x) d_x L_t^x$ for symmetric α stable processes

as a Young integral as well as a rough path integral.

The rest of the paper is organized as follows. In Section 2 we recall some results from the Young's integration theory and establish a Young integral of local time. In Section 3 we recall some results from the rough path theory and establish a rough path integral of local time.

2. The Young integral

We first recall the definition of the bounded p-variation (see e.g. [37], [24]).

Definition 2.1. A function $f:[x',x''] \to \mathbb{R}$ is of bounded p-variation if

$$\sup_{E} \sum_{i=1}^{m} |f(x_i) - f(x_{i-1})|^p < \infty$$
(2.1)

where $E := \{x' = x_0 < x_1 < \dots < x_m = x''\}$ is an arbitrary partition of [x', x'']. Here $p \ge 1$ is a fixed real number.

We present Young's integration theorem from [37] in the following.

Theorem 2.2. (Young integral) Consider a function f of finite p-variation and a function g of finite q-variation where $p,q>0,\frac{1}{p}+\frac{1}{q}>1$, such that f(x) and g(x) have no common discontinuities, then

$$\int_{x'}^{x''} f(x)dg(x) = \lim_{m(E)\to 0} \sum_{i=1}^{m} f(\xi_i) (g(x_i) - g(x_{i-1}))$$
(2.2)

is well defined. Here $\xi_i \in [x_{i-1}, x_i], m(E) = \sup_{1 \le i \le m} (x_i - x_{i-1}).$

We also recall the integration of a sequence of functions which is also due to Young (see [37]).

Theorem 2.3. (Term by term integration) Let $\{f_n\}$ be a sequence of functions of finite p-variation converging densely to a function f of finite p-variation uniformly at each point of a set A. Let $\{g_n\}$ be a sequence of functions of finite q-variation converging densely, and at x', x'' to a function g of finite q-variation uniformly at each point of a set B. Suppose further that $p, q > 0, \frac{1}{p} + \frac{1}{q} > 1$, and that A includes the discontinuities of g, B those of f, $A \cup B$ represents all points of (x', x''). Then as $n \to \infty$

$$\int_{x'}^{x''} f_n dg_n \to \int_{x'}^{x''} f dg. \tag{2.3}$$

2.1. Fractional derivative and fractional Laplacian

We first recall the definition of the α^{th} right fractional integral of a function g from [31]. The left fractional integral is defined similarly. The Riemann's definition of fractional integral for a suitable function g is

$${}_{a}I_{x}^{\alpha}g(x) = \frac{1}{\Gamma(\alpha)} \int_{a}^{x} (x-u)^{\alpha-1}g(u)du, \tag{2.4}$$

for almost all x with $-\infty \le a < x < \infty$ and $\text{Re}(\alpha) > 0$, where α is a complex number in general and Re denotes its real part. For a = 0, this is a Riemann-Liouville fractional integral

$${}_{0}I_{x}^{\alpha}g(x) = \frac{1}{\Gamma(\alpha)} \int_{0}^{x} (x-u)^{\alpha-1}g(u)du, \qquad Re(\alpha) > 0.$$

$$(2.5)$$

A sufficient condition ensures the convergence of integral (2.5) is that $g(\frac{1}{x}) = O(x^{1-\eta})$, $\eta > 0$. Functions with the above property are sometimes called functions of the Riemann class. For instance, constants are of Riemann class as well as functions such as x^m , with m > -1. For $a = -\infty$, this is the Liouville fractional integral

$${}_{-\infty}I_x^{\alpha}g(x) = \frac{1}{\Gamma(\alpha)} \int_{-\infty}^x (x-u)^{\alpha-1}g(u)du, \qquad \operatorname{Re}(\alpha) > 0.$$
 (2.6)

A sufficient condition ensures the converges of integral (2.6) is that $g(-x) = O(x^{-\alpha-\eta})$, $\eta > 0$, $x \to \infty$. Functions with the above property are sometimes called functions of the Liouville class. For example, functions such as x^m , with $m < -\alpha < 0$ are of the Liouville class. The fractional integral operator satisfy the semigroup property, namely

$$_{a}I_{x}^{\alpha}(_{a}I_{x}^{\beta}) =_{a}I_{x}^{\alpha+\beta}, \qquad \operatorname{Re}(\alpha,\beta) > 0.$$

The right fractional derivative operator and left fractional derivative operator are defined in terms of the right fractional integral operator and left fractional integral operator in the following manner

$$_{a}\nabla_{x}^{\alpha} = \frac{d^{n}}{dx^{n}} \left({_{a}I_{x}^{n-\alpha}} \right), \qquad \operatorname{Re}(\alpha) > 0, n = \lfloor \operatorname{Re}(\alpha) \rfloor + 1,$$
 (2.7)

and

$$_{x}\nabla_{a}^{\alpha} = (-1)^{n} \frac{d^{n}}{dx^{n}} \left({_{x}I_{a}^{n-\alpha}} \right), \quad \operatorname{Re}(\alpha) > 0, n = \lfloor \operatorname{Re}(\alpha) \rfloor + 1.$$
 (2.8)

Next, we recall the definition of the Riesz fractional derivative in the following

Definition 2.4. (see e.g. [32]) The Riesz fractional derivative for $0 < \alpha < 2$ and for $-\infty < x < \infty$ is defined as $\nabla^{\alpha} g(x) = -c_{\alpha}(-\infty \nabla^{\alpha}_{x} + {}_{x}\nabla^{\alpha}_{\infty})g(x)$, where

$$c_{\alpha} = \frac{1}{2\cos(\frac{\pi\alpha}{2})}, \ \alpha \neq 1,$$

$$-\infty \nabla_{x}^{\alpha} g(x) = \frac{1}{\Gamma(n-\alpha)} \frac{d^{n}}{dx^{n}} \int_{-\infty}^{x} \frac{g(u)}{(x-u)^{\alpha+1-n}} du,$$

$${}_{x} \nabla_{\infty}^{\alpha} g(x) = (-1)^{n} \frac{1}{\Gamma(n-\alpha)} \frac{d^{n}}{dx^{n}} \int_{x}^{\infty} \frac{g(u)}{(u-x)^{\alpha+1-n}} du,$$

where $n = \lfloor \operatorname{Re}(\alpha) \rfloor + 1$.

For a function g satisfying the integrability condition

$$\int_{\mathbb{R}} \frac{|g(y)|}{(1+|y|)^{1+\alpha}} dy < \infty, \tag{2.9}$$

we define as in [7] that

$$\triangle_{\epsilon}^{\frac{\alpha}{2}}g(x) = \mathcal{A}(1, -\alpha) \int_{|y-x| > \epsilon} \frac{g(y) - g(x)}{|y-x|^{1+\alpha}} dy, \tag{2.10}$$

and

$$\triangle^{\frac{\alpha}{2}}g(x) = \mathcal{A}(1, -\alpha)P.V. \int_{\mathbb{R}} \frac{g(y) - g(x)}{|y - x|^{1+\alpha}} dy := \lim_{\epsilon \to 0^+} \triangle^{\frac{\alpha}{2}}_{\epsilon}g(x), \tag{2.11}$$

whenever the limit exists. Here "P.V." stands for the "principal value". The above limit exists and is finite if g is of class C^2 in a neighborhood of x and satisfies condition (2.9); in this case

$$\triangle^{\frac{\alpha}{2}}g(x) = \mathcal{A}(1, -\alpha) \int_{\mathbb{R}} \frac{g(y) - g(x) - \nabla g(x) \cdot (y - x) \mathbf{1}_{\{|y - x| < \epsilon\}}}{|y - x|^{1 + \alpha}} dy$$

for any $\epsilon > 0$, where $\mathcal{A}(1, -\alpha) = \frac{\alpha 2^{\alpha-1} \Gamma(\frac{\alpha+1}{2})}{\pi^{\frac{1}{2}} \Gamma(1-\frac{\alpha}{2})}$. Here $\triangle^{\frac{\alpha}{2}}$, is the fractional power of the Laplace operator $-(-\triangle)^{\frac{\alpha}{2}}$. The Fractional Laplacian is the infinitesimal generator of α stable process (see e.g. [18]). The Fractional Laplacian is usually defined by its Fourier transform (cf. [33]): $\mathcal{F}((-\triangle)^{\frac{\alpha}{2}}g)(\xi) = |\xi|^{\alpha}\mathcal{F}(g)(\xi)$, its proof can be found in [18]. Hence, $-(-\triangle)^{\frac{\alpha}{2}}g(\xi) = -\mathcal{F}^{-1}(|\xi|^{\alpha}\mathcal{F}(g)(\xi))$. The definition we used in (2.11) coincides with the usual Fractional Laplacian defined by its Fourier transform (see [1]).

By the Fourier transform method, one could show that the following relation holds (cf. [11]):

$$-(-\triangle)^{\frac{\alpha}{2}}g(x) = \nabla^{\alpha}g(x).$$

2.2. p-variation of local time of symmetric stable process

We present the exact modulus of local time of stable processes from [4] in the following theorem. Recall its characteristic function is given by

$$\chi(\theta) = |\theta|^{\alpha} + ih|\theta|^{\alpha} sqn(\theta),$$

where $|h| \leq \tan(\alpha \pi/2)$. We define its local time as L_t^x .

Theorem 2.5. For a symmetric stable process of index $\alpha > 1$, its local time satisfies

$$\lim_{\substack{\delta \downarrow 0 \\ a,b \in I \\ 0 \le s \le t}} \frac{|L_s^a - L_s^b|}{|b - a|^{\frac{\alpha - 1}{2}} \left(\log\left(\frac{1}{|b - a|}\right)\right)^{1/2}} = \frac{2c_{\alpha}^{1/2}}{(1 + h^2)^{1/2}} \left(\sup_{x \in I} L_t^x\right)^{1/2},\tag{2.12}$$

for all intervals $I \subseteq \mathbb{R}$ and all t > 0 a.s., where

$$c_{\alpha} = \frac{2}{\pi} \int_{0}^{\infty} (1 - \cos y) y^{-\alpha} dy = \frac{1}{\pi} \frac{\Gamma(2 - \alpha)}{\alpha - 1} \sin \frac{(2 - \alpha)\pi}{2}.$$
 (2.13)

Barlow [4] gave a neccessary and sufficient condition for the joint continuity of the local time, and the exact modulus for a fairly wide class of Lévy processes.

Let [a, b] be any finite interval. By its dyadic decompositions we mean partitions $\{a_0^n < a_1^n < \cdots < a_{2^n}^n\}$ of [a, b], where

$$a_k^n = a + \frac{k}{2^n}(b-a), \ k = 0, 1, \dots, 2^n,$$

and $n \in \mathbb{N}$.

Proposition 2.6. The family of local times L_t^x of α -stable processes with $\alpha \in (1,2)$ is of bounded p-variation in x for any $t \geq 0$, and any $p > \frac{2}{\alpha - 1}$ almost surely.

Proof. First from Theorem 2.5, we know that for almost all $\omega \in \Omega$, there exists a $\delta^*(\omega) > 0$ such that when $0 < |b - a| < \delta^*(\omega)$, we have the following

$$|L_s^a - L_s^b|^p \le \left| b - a \right|^{\frac{(\alpha - 1)p}{2}} \left(\log \left(\frac{1}{|b - a|} \right) \right)^{\frac{p}{2}} \frac{2^{p+1} c_{\alpha}^{\frac{p}{2}}}{\left(1 + h^2 \right)^{\frac{p}{2}}} \left(\sup_{x \in I} L_t^x \right)^{\frac{p}{2}}. \tag{2.14}$$

We can construct a dyadic decomposition which fully covers the interval [a, b]. Furthermore, by Proposition 4.1.1 from [24] (set $i = 1, \gamma = p - 1$), for any partition $\{a_l\}$ of [a, b], we have

$$\sup_{D} \sum_{l} |L_{t}^{a_{l+1}} - L_{t}^{a_{l}}|^{p} \le C(p, \gamma) \sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| L_{t}^{a_{k}^{n}} - L_{t}^{a_{k-1}^{n}} \right|^{p}, \tag{2.15}$$

where $C(p, \gamma)$ is a constant depending on p and γ . Notice the right hand side of (2.15) does not depend on partition D.

We can choose an n_0 big enough such that $\frac{|b-a|}{2^n} \leq \delta^*(\omega)$ for any $n \geq n_0$. By substituting (2.14) into (2.15), it follows that

$$\begin{split} &\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| L_{t}^{a_{k}^{n}} - L_{t}^{a_{k-1}^{n}} \right|^{p} \\ &\leq \sum_{n=1}^{n_{0}-1} n^{\gamma} \sum_{k=1}^{2^{n}} \left| L_{t}^{a_{k}^{n}} - L_{t}^{a_{k-1}^{n}} \right|^{p} \\ &+ \sum_{n=n_{0}}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| a_{k}^{n} - a_{k-1}^{n} \right|^{\frac{(\alpha-1)p}{2}} \left(\log \left(\frac{1}{|a_{k}^{n} - a_{k-1}^{n}|} \right) \right)^{\frac{p}{2}} \frac{2^{p+1} c_{\alpha}^{\frac{p}{2}}}{\left(1 + h^{2} \right)^{\frac{p}{2}}} \left(\sup_{x \in I} L_{t}^{x} \right)^{\frac{p}{2}}. \end{split}$$

In [3], Barlow showed that

$$\left(\sup_{x\in I} L_t^x\right)^{\frac{p}{2}} < \infty, \quad a.s.. \tag{2.16}$$

Now, we consider the term

$$\sum_{n=n_0}^{\infty} n^{\gamma} \sum_{k=1}^{2^n} \left| a_k^n - a_{k-1}^n \right|^{\frac{(\alpha-1)p}{2}} \left(\log \left(\frac{1}{|a_k^n - a_{k-1}^n|} \right) \right)^{\frac{p}{2}}$$

where $a_k^n = \frac{k}{2^n}(b-a) + a$, $k = 0, 1, \dots, 2^n$, then it is not difficult to see that

$$\begin{split} &\sum_{n=n_0}^{\infty} n^{\gamma} \sum_{k=1}^{2^n} \left| a_k^n - a_{k-1}^n \right|^{\frac{(\alpha-1)p}{2}} \left(\log \left(\frac{1}{|a_k^n - a_{k-1}^n|} \right) \right)^{\frac{p}{2}} \\ &= \sum_{n=n_0}^{\infty} n^{\gamma} \sum_{k=1}^{2^n} \left| a_k^n - a_{k-1}^n \right|^{\frac{(\alpha-1)p}{4} + \frac{1}{2}} \left| a_k^n - a_{k-1}^n \right|^{\frac{(\alpha-1)p}{4} - \frac{1}{2}} \left(\log \left(\frac{1}{|a_k^n - a_{k-1}^n|} \right) \right)^{\frac{p}{2}} \\ &\leq \beta_1 \sum_{n=n_0}^{\infty} n^{\gamma} \left(\frac{b-a}{2^n} \right)^{\frac{(\alpha-1)p}{4} - \frac{1}{2}} \end{split}$$

where β_1 is a constant depends only on p. It turns out for any interval $[a,b] \subset \mathbb{R}$

$$\sup_{D} \sum_{m} |L_t^{a_{m+1}} - L_t^{a_m}|^p < \infty.$$

As $L^a_t(\omega)$ has a compact support in a for each ω , say [-N,N] contains its support. We still denote its partition by $D:=D_{-N,N}=\{-N=x_0< x_1< \cdots < x_t=N\}$ and attain that

$$\sup_{D} \sum_{l} |L_{t}^{a_{l+1}} - L_{t}^{a_{l}}|^{p} < \infty. \tag{2.17}$$

2.3. The Young integral with respect to local time

We start with functions which are smooth, then proceed to functions which are less smooth. The following works for sufficiently smooth functions, unless we explicitly say otherwise. Itô's formula for Lévy process in general (cf. [2]) is given by

$$g(X_{t}) = g(X_{0}) + \int_{0}^{t} \nabla g(X_{s}) dX_{s} + \frac{1}{2} \sigma^{2} \int_{0}^{t} \triangle g(X_{s}) ds$$

$$+ \int_{0}^{t} \int_{\mathbb{R}} \left[g(X_{s-} + y) - g(X_{s-}) \right] 1_{\{|y| \ge 1\}} N(dy, ds)$$

$$+ \int_{0}^{t} \int_{\mathbb{R}} \left[g(X_{s-} + y) - g(X_{s-}) \right] 1_{\{|y| < 1\}} \tilde{N}(dy, ds)$$

$$+ \int_{0}^{t} \int_{\mathbb{R}} \left[g(X_{s-} + y) - g(X_{s-}) - y \nabla g(X_{s-}) \right] 1_{\{|y| < 1\}} \nu(dy) ds,$$

$$(2.18)$$

where $\tilde{N}(dy, ds)$ is the compensated Poisson measure defined as the difference of Poisson point measure N(dy, ds) and its intensity measure $\nu(dy) ds$. And, the Lévy measure of stable process $\nu(dx)$ is

$$\nu(dx) = C|x|^{-\alpha - 1}dx,$$

where C is a constant. The last term of the above Itô's formula can be further simplified by using the definition of fractional Laplacian as

$$\begin{split} &\int_{\mathbb{R}\backslash\{0\}} \left[g(X_{s-} + y) - g(X_{s-}) - y \nabla g(X_{s-}) \right] \mathbf{1}_{\{|y| < 1\}} \nu(dy) \\ &= C \int_{\mathbb{R}\backslash\{0\}} \frac{g(X_{s-} + y) - g(X_{s-}) - y \nabla g(X_{s-}) \mathbf{1}_{|y| < 1}}{|y|^{\alpha + 1}} dy - C \int_{|y| \ge 1} \frac{g(X_{s-} + y) - g(X_{s-})}{|y|^{\alpha + 1}} dy \\ &= C_{\alpha} \triangle^{\frac{\alpha}{2}} g(X_{s-}) - \int_{|y| > 1} [g(X_{s-} + y) - g(X_{s-})] \nu(dy) \end{split}$$

for every $g \in C_b^2(\mathbb{R})$, where $C_\alpha = \frac{C\pi^{\frac{1}{2}}\Gamma(1-\frac{2}{\alpha})}{\alpha 2^{\alpha-1}\Gamma(\frac{1+\alpha}{2})}$.

Then, one can derive the following Itô's formula for stable processes from (2.18) based on the fact that $\sigma = 0$ for stable processes which are pure jump processes and the definition of the compensated Poisson measure

$$g(X_t) = g(X_0) + \int_0^t \nabla g(X_s) dX_s$$

$$+ \int_0^t \int_{\mathbb{R} \setminus \{0\}} \left[g(X_{s-} + y) - g(X_{s-}) \right] \tilde{N}(dy, ds)$$

$$+ C_\alpha \int_0^t \triangle^{\frac{\alpha}{2}} g(X_{s-}) ds. \tag{2.19}$$

By the occupation times formula, one can show that

$$\int_0^t \nabla^\alpha g(X_{s-}) ds = \int_{-\infty}^\infty \nabla^\alpha g(x) L_t^x dx = \int_{-\infty}^\infty L_t^x d_x \left(\nabla^{\alpha - 1} g(x) \right). \tag{2.20}$$

Note the last integral $\int_{-\infty}^{\infty} L_t^x d_x \left(\nabla^{\alpha-1} g(x) \right)$ can be defined without the need to assume that $g \in C^2$. In fact, if $\nabla^{\alpha-1} g(x)$ is of finite q-variation $(1 \le q < \frac{2}{3-\alpha})$, then the integral $\int_{-\infty}^{\infty} \nabla^{\alpha-1} g(x) d_x L_t^x$ is well defined as a Young integral. Similar to [12], we have the following remark.

Remark 2.7. If $\nabla^{\alpha-1}g(x)$ is a C^1 function, then $\int_{-\infty}^{\infty} \nabla^{\alpha-1}g(x)d_xL_t^x$ exists as a Riemann integral and we have

$$\int_{-\infty}^{\infty} \nabla^{\alpha - 1} g(x) d_x L_t^x = -\int_{-\infty}^{\infty} L_t^x d_x \left(\nabla^{\alpha - 1} g(x) \right). \tag{2.21}$$

In fact, since L_t has a compact support for each t, one can always add some points in the partition to make $L_t^{x_1} = 0$ and $L_t^{x_m} = 0$. Then, we can show that

$$\int_{-\infty}^{\infty} \nabla^{\alpha-1} g(x) d_x L_t^x
= \lim_{m(D) \to 0} \sum_{j=1}^{m} \nabla^{\alpha-1} g(x_{j-1}) \left(L_t^{x_j} - L_t^{x_{j-1}} \right)
= \lim_{m(D) \to 0} \left[\sum_{j=1}^{m} \nabla^{\alpha-1} g(x_{j-1}) L_t^{x_j} - \sum_{j=0}^{m-1} \nabla^{\alpha-1} g(x_j) L_t^{x_j} \right]
= -\lim_{m(D) \to 0} \sum_{j=1}^{m} \left(\nabla^{\alpha-1} g(x_j) - \nabla^{\alpha-1} g(x_{j-1}) \right) L_t^{x_j}
= -\int_{-\infty}^{\infty} L_t^x d_x \left(\nabla^{\alpha-1} g(x) \right).$$
(2.22)

In the following, we will consider the integral for less smooth functions. For this, we define a mollifier

$$\rho(x) = \begin{cases} ce^{\frac{1}{(x-1)^2 - 1}}, & if \ x \in (0,2), \\ 0, & otherwise. \end{cases}$$
 (2.23)

Here c is chosen so that $\int_0^2 \rho(x)dx = 1$. Take $\rho_n(x) = n\rho(nx)$ as the mollifier which will be used to smootherise less smooth functions.

In this paper, we extend Itô's formula for less smooth function $f: \mathbb{R} \to \mathbb{R}$ which is absolutly continuous. Such function f has a $(\alpha - 1)^{th}$ fractional derivative which is assumed to be left continuous and is of finite q variation, where $1 \le q < 4$. And, we denote the left limit of this $(\alpha - 1)^{th}$ fractional derivative of f as $\nabla_{-}^{\alpha-1}f(x)$.

Theorem 2.8. Let $f: \mathbb{R} \to \mathbb{R}$ be an absolutely continuous, locally bounded function, have the $(\alpha - 1)^{th}$ fractional derivative which is left continuous and of finite q-variation, where $1 \le q < \frac{2}{3-\alpha}$. Define $f_n(x) = \int_{-\infty}^{\infty} \rho_n(x-y)f(y)dy$ with $n \ge 1$. Then

$$\int_{-\infty}^{\infty} \nabla^{\alpha-1} f_n(x) d_x L_t^x \to \int_{-\infty}^{\infty} \nabla_{-}^{\alpha-1} f(x) d_x L_t^x, \quad as \quad n \to \infty.$$
 (2.24)

Proof. Note that $f_n(x)$ can be rewritten as

$$f_n(x) = \int_0^2 \rho(z) f(x - \frac{z}{n}) dz, \quad n \ge 1,$$

and note it is smooth. In particular

$$\nabla^{\alpha-1} f_n(x) = \int_0^2 \rho(z) \nabla^{\alpha-1} f(x - \frac{z}{n}) dz, \quad n \ge 1.$$
 (2.25)

To see this, one can use Fubini's theorem and the absolutely continuity property of the function f to get

$$-\infty \nabla_x^{\alpha-1} f_n(x) = \frac{1}{\Gamma(2-\alpha)} \frac{d}{dx} \left(\int_{-\infty}^x \frac{f_n(t)}{(x-t)^{\alpha-1}} dt \right)$$

$$= \frac{1}{\Gamma(2-\alpha)} \frac{d}{dx} \left(\int_0^\infty \frac{f_n(x-t)}{t^{\alpha-1}} dt \right)$$

$$= \frac{1}{\Gamma(2-\alpha)} \left(\int_0^\infty \frac{f_n'(x-t)}{t^{\alpha-1}} dt \right)$$

$$= \frac{1}{\Gamma(2-\alpha)} \left(\int_{-\infty}^x (x-t)^{1-\alpha} \int_0^2 \rho(z) f'(t-\frac{z}{n}) dz dt \right)$$

$$= \frac{1}{\Gamma(2-\alpha)} \left(\int_0^2 \rho(z) \int_{-\infty}^x \frac{f'(t-\frac{z}{n})}{(x-t)^{\alpha-1}} dt dz \right)$$

$$= \frac{1}{\Gamma(2-\alpha)} \left(\int_0^2 \rho(z) \frac{d}{dx} \left(\int_{-\infty}^x \frac{f(t-\frac{z}{n})}{(x-t)^{\alpha-1}} dt \right) dz \right)$$

$$= \int_0^2 \rho(z)_{-\infty} \nabla_x^{\alpha-1} f(x-\frac{z}{n}) dz. \tag{2.26}$$

Similarly, we can derive $_x \nabla_{\infty}^{\alpha-1} f_n(x) = \int_0^2 \rho(z)_x \nabla_{\infty}^{\alpha-1} f(x-\frac{z}{n}) dz$. Hence, we have proved (2.25). Similar to [38], for any partition $D := \{-N = x_0 < x_1 < \dots < x_r = N\}$, there is an increasing function w such that

$$\left| \nabla^{\alpha-1} f(x_{l+1}) - \nabla^{\alpha-1} f(x_l) \right| \le \left(\mathbf{w}(x_{l+1}) - \mathbf{w}(x_l) \right)^{\frac{1}{q}}, \quad x_l, \ x_{l+1} \in D_q$$

where $\mathbf{w}(x)$ is the total q-variation of $\nabla^{\alpha-1} f(x)$ in the interval [-N-2, x].

Then, by Jensen's inequality, we obtain

$$\sup_{D} \sum_{l=1}^{r} \left| \nabla^{\alpha-1} f_{n}(x_{l}) - \nabla^{\alpha-1} f_{n}(x_{l-1}) \right|^{q}$$

$$= \sup_{D} \sum_{l=1}^{r} \left| \int_{0}^{2} \rho(z) \left[\nabla^{\alpha-1} f(x_{l} - \frac{z}{n}) - \nabla^{\alpha-1} f(x_{l-1} - \frac{z}{n}) \right] dz \right|^{q}$$

$$\leq M_{1} \sup_{D} \sum_{l=1}^{r} \left(\int_{0}^{2} \left| \nabla^{\alpha-1} f(x_{l} - \frac{z}{n}) - \nabla^{\alpha-1} f(x_{l-1} - \frac{z}{n}) \right|^{q} dz \right)$$

$$\leq M_{1} \int_{0}^{2} \sup_{D} \sum_{l=1}^{r} \left| \nabla^{\alpha-1} f(x_{l} - \frac{z}{n}) - \nabla^{\alpha-1} f(x_{l-1} - \frac{z}{n}) \right|^{q} dz$$

$$\leq M_{1} \int_{0}^{2} \left(\mathbf{w}(N - \frac{z}{n}) - \mathbf{w}(-N - \frac{z}{n}) \right) dz,$$

$$(2.27)$$

where M_1 is a constant. In addition, as we have

$$\mathbf{w}(N - \frac{z}{n}) - \mathbf{w}(-N - \frac{z}{n}) \le \mathbf{w}(N), \tag{2.28}$$

it follows that

$$\sup_{D} \sum_{l=1}^{r} \left| \nabla^{\alpha - 1} f_n(x_l) - \nabla^{\alpha - 1} f_n(x_{l-1}) \right|^q \le 2M_1 \mathbf{w}(N) < \infty.$$
 (2.29)

This implies that $\nabla^{\alpha-1} f_n(x)$ is of bounded q-variation in x uniformly in n. Moreover, by Lebesgue's dominated convergence theorem and (2.27), we have that

$$\nabla^{\alpha-1} f_n(x) \to \nabla_-^{\alpha-1} f(x) \quad \text{as} \quad n \to \infty.$$
 (2.30)

Now the theorem follows from Theorem 2.3 immediately.

We present the Itô's formula for stable processes defined in terms of Young integral in the following theorem.

Theorem 2.9. Let $X = (X_t)_{t \geq 0}$ be a symmetric α -stable process, $1 < \alpha < 2$, and $f : \mathbb{R} \to \mathbb{R}$ be an absolutely continuous, locally bounded function that has $(\alpha - 1)^{th}$ fractional order derivative $\nabla^{\alpha - 1}_{-} f(x)$. Assume that $\nabla^{\alpha - 1}_{-} f(x)$ is locally bounded, and of bounded q-variation, where $1 \leq q < \frac{2}{3-\alpha}$. Then we have the following Itô's formula

$$f(X_{t}) = f(X_{0}) + \int_{0}^{t} \nabla_{-}f(X_{s})dX_{s}$$

$$+ \int_{0}^{t} \int_{\mathbb{R}} \left(f(X_{s-} + y) - f(X_{s-}) \right) \tilde{N}(dy, ds) - C_{\alpha} \int_{-\infty}^{\infty} \nabla_{-}^{\alpha - 1} f(x) d_{x} L_{t}^{x},$$
(2.31)

where $C_{\alpha} = \frac{\pi^{\frac{1}{2}}\Gamma(1-\frac{2}{\alpha})}{\alpha 2^{\alpha-1}\Gamma(\frac{1+\alpha}{2})}$.

Proof. Define a smooth function f_n as in Theorem 2.8. We apply Itô's formula (2.19) for stable process to the smooth function f_n . Then when we take the limit as $n \to \infty$, the convergence of all terms except the fractional Laplacian term are clear. For the fractional Laplacian term, we use the occupation times formula, Remark 2.7 and equation (2.24), to obtain that

$$\int_0^t \triangle^{\frac{\alpha}{2}} f_n(X_{s-}) ds = -\int_{-\infty}^\infty \nabla^{\alpha-1} f_n(x) d_x L_t^x \to -\int_{-\infty}^\infty \nabla_-^{\alpha-1} f(x) d_x L_t^x. \tag{2.32}$$

3. Local time as rough path

For a function g is of bounded q-variation for $1 \leq q < \frac{2}{3-\alpha}$ and local time is of bounded p-variation $(p > \frac{2}{\alpha-1})$, one can find a real number $p > \frac{2}{\alpha-1}$ such that $\frac{1}{p} + \frac{1}{q} > 1$, hence $\int_{-\infty}^{\infty} g(x) d_x L_t^x$ can be defined as a Young integral. But when $q \geq \frac{2}{3-\alpha}$, the condition $\frac{1}{p} + \frac{1}{q} > 1$ is not satisfied, hence one can no longer use Young integral to define $\int_{-\infty}^{\infty} g(x) d_x L_t^x$. Moreover, $\int L_t^x dL_t^x$ cannot be defined as a Young integral as pointed out in [13, 14]. However, the rough path integration theory can provide a way to overcome this obstacle. In the rest of the paper, we deal with the case where $\frac{3}{2} < \alpha < 2$ and $\frac{2}{3-\alpha} \leq q < 4$. For this, one needs to treat $Z_x := (L_t^x, g(x))$ as a process of variable x in \mathbb{R}^2 . In this case, Z_x is of bounded \hat{q} -variation in x, where $\hat{q} = max\{p,q\}$ with $p \in (\frac{2}{\alpha-1},4)$.

In the following, we will first construct a continuous and bounded path Z(m) from Z on a certain time interval. The smooth rough path $\mathbf{Z}(m)$ is thus built by taking its iterated integrals with respect to Z(m). The final stage is to show the existence of the geometric rough path $\mathbf{Z} = (\mathbf{1}, \mathbf{Z}^1, \mathbf{Z}^2, \mathbf{Z}^3)$ associated with Z.

In order to show the existence of the geometric rough path \mathbf{Z} , we need to prove that the space of rough path we have defined is complete under the θ -variation distance which was pointed out in Lemma 3.3.3 in [24]

$$d_{\theta}(X,Y) = \max_{1 \le i \le [\theta]} d_{i,\theta}(X^{i}, Y^{i}) = \max_{1 \le i \le [\theta]} \sup_{D} \left(\sum_{l} |X_{x_{l-1}, x_{l}}^{i} - Y_{x_{l-1}, x_{l}}^{i}|^{\frac{\theta}{i}} \right)^{\frac{1}{\theta}}.$$
 (3.1)

Therefore, the strategy consists of verifying that the smooth rough path $\mathbf{Z}(m)$ is a Cauchy sequence in the θ -variation metric d_{θ} on $C_{0,\theta}(\Delta, T^{([\theta])}(\mathbb{R}^2))$.

We recall the following lemma from [27].

Lemma 3.1. Let $X = \{X(t), t \in \mathbb{R}_+\}$ be a real-valued symmetric stable process of index $1 < \alpha \le 2$ and $\{L_t^x, (t, x) \in \mathbb{R}_+ \times \mathbb{R}\}$ be the local time of X. Then, for all $x, y \in \mathbb{R}$, and integers $m \ge 1$,

$$||L_t^x - L_t^y||_{2m} \le C(\alpha, m) t^{\frac{\alpha - 1}{2\alpha}} |x - y|^{\frac{\alpha - 1}{2}},$$
 (3.2)

where $C(\alpha, m)$ is constant depending on α and m.

We obtain that for any $p > \frac{2}{\alpha-1}$, the following relation as a speical case of Lemma 3.1

$$E|L_t^b - L_t^a|^p \le c|b - a|^{\frac{(\alpha - 1)p}{2}},$$
 (3.3)

with a constant c > 0. This means that L_t^x satisfies the Hölder condition with exponent $\frac{\alpha-1}{2}$. A control function \mathbf{w} is a non-negative continuous function on the simplex $\Delta := \{(a,b) : x' \leq a < b \leq x''\}$ with values in $[0,\infty)$ such that $\mathbf{w}(a,a) = 0$. It is super-additive, namely

$$\mathbf{w}(a,b) + \mathbf{w}(b,c) \le \mathbf{w}(a,c),\tag{3.4}$$

for any $(a,b),(b,c)\in\Delta$. In the case when g(x) is of bounded q-variation, one has a control w such that

$$|g(b) - g(a)|^q \le \mathbf{w}(a, b), \tag{3.5}$$

for any $(a,b) \in \Delta$. It is clear that $\mathbf{w}_1(a,b) := \mathbf{w}(a,b) + (b-a)$ is also a control of g. For $h = \frac{1}{\hat{q}}$ and $\theta > \hat{q}$, one can verify that

$$|g(b) - g(a)|^{\theta} \le \mathbf{w}_1(a, b)^{h\theta} \tag{3.6}$$

for any $(a,b) \in \Delta$ and $h\theta > 1$. Hence, there exists a constant c such that

$$E|Z_b - Z_a|^{\theta} < c\mathbf{w}_1(a,b)^{h\theta}, \quad \forall (a,b) \in \Delta.$$
 (3.7)

Following the idea in [13], one could define a continuous and bounded variation path Z(m) on [x', x''] for any $m \in N$ by

$$Z(m)_x := Z_{x_{l-1}^m} + \frac{\mathbf{w}_1(x) - \mathbf{w}_1(x_{l-1}^m)}{\mathbf{w}_1(x_l^m) - \mathbf{w}_1(x_l^m)} \Delta_l^m Z, \tag{3.8}$$

where $x_{l-1}^m \le x < x_l^m$ with $l = 1, ..., 2^m$, and $\Delta_l^m Z = Z_{x_l^m} - Z_{x_{l-1}^m}$. Take a partition $D_m := \{x' = x_0^m < x_1^m < \cdots < x_{2^m}^m = x''\}$ of [x', x''] such that

$$\mathbf{w}_1(x_l^m) - \mathbf{w}_1(x_{l-1}^m) = \frac{1}{2^m} \mathbf{w}_1(x', x''), \tag{3.9}$$

where $\mathbf{w}_1(x) := \mathbf{w}_1(x', x)$. In addition, by the superadditivity of the control function \mathbf{w}_1 , it is clear that

$$\mathbf{w}_1(x_{l-1}^m, x_l^m) \le \mathbf{w}_1(x_l^m) - \mathbf{w}_1(x_{l-1}^m) = \frac{1}{2^m} \mathbf{w}_1(x', x'').$$

The smooth rough path $\mathbf{Z}(m)$ associated with Z(m) is constructed by taking its iterated path integrals. That is

$$\mathbf{Z}(m)_{a,b}^{j} = \int_{a < x_1 < \dots < x_j < b} dZ(m)_{x_1} \otimes \dots \otimes dZ(m)_{x_j}$$
(3.10)

for any $(a, b) \in \Delta$, where j = 0, 1, 2, 3.

We will need the slightly modified version of Proposition 4.1.1 from [24].

Proposition 3.2. Let $Z \in C_0(\Delta, T^{(N)}(V))$ be a multiplicative functional with a fixed running time interval, say [0,1]. Then for any $1 \le i \le N$, θ satisfying $\theta/i > 1$, and any $\gamma > \theta/i - 1$, there exists a constant $C_i(\theta, \gamma)$ depending only on θ, γ , and i, such that

$$\sup_{D} \sum_{l} |Z_{x_{l-1},x_{l}}^{i}|^{\theta/i} \le C_{i}(\theta,\gamma) \sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \sum_{j=1}^{i} |Z_{x_{k-1},x_{k}}^{j}|^{\theta/j}, \tag{3.11}$$

where \sup_{D} runs over all finite partitions D of [0,1], and x_n^k satisfies equation (3.9).

The aim of the remaining part of this section is to prove that $\{\mathbf{Z}(m)\}_{m\in\mathbb{N}}$ converges to a geometric rough path \mathbf{Z} in the θ -variation topology.

3.1. First level path

We first consider the convergence of the first level path $\mathbf{Z}(m)_{a,b}^1$.

Proposition 3.3. Let (Z_x) be a continuous path and $h\theta \geq 1$, $\mathbf{Z}(m)$ be defined as above. Then for all $n \in N$

$$m \to \sum_{k=1}^{2^n} |\mathbf{Z}(m)_{x_{k-1}^n, x_k^n}^1|^{\theta}$$
 (3.12)

is increasing. Hence,

$$\sup_{m} \sum_{k=1}^{2^{n}} |\mathbf{Z}(m)_{x_{k-1}, x_{k}^{n}}^{1}|^{\theta} = \lim_{m \to \infty} \sum_{k=1}^{2^{n}} |\mathbf{Z}(m)_{x_{k-1}, x_{k}^{n}}^{1}|^{\theta}.$$
(3.13)

Proof. By (3.8) and (3.10), we can derive for $n \leq m$

$$\mathbf{Z}(m)_{x_{k-1},x_k^n}^1 = \Delta_k^n Z, \quad k = 1,\dots,2^n.$$

On the other hand, if n > m, it is possible to find a unique integer $1 \le l \le 2^m$ satisfying

$$x_{l-1}^m \le x_{k-1}^n < x_k^n < x_l^m. (3.14)$$

Based on (3.8) and (3.10), one can get

$$Z(m)_{x_j^n} = Z_{x_{l-1}^m} + \frac{\mathbf{w}_1(x_j^n) - \mathbf{w}_1(x_{l-1}^m)}{\mathbf{w}_1(x_l^m) - \mathbf{w}_1(x_l^m)} \Delta_l^m Z, \quad j = k - 1, k.$$
(3.15)

It turns out that

$$\mathbf{Z}(m)_{x_{k-1}^n, x_k^n}^1 = Z(m)_{x_k^n} - Z(m)_{x_{k-1}^n} = 2^{m-n} \Delta_l^m Z, \quad \forall n > m.$$
(3.16)

For n > m, from the inequality (3.14), we can compute the range for the integer k for a given integer l. That is $2^{n-m}(l-1)+1 \le k < 2^{n-m}l$. In other words, there are 2^{n-m} points of the form of $\{x_k^n\}_{2^{n-m}(l-1)+1 \le k < 2^{n-m}l}$ embedded inside $[x_{l-1}^m, x_l^m)$. Therefore, for n > m,

$$\sum_{k=1}^{2^{n}} |\mathbf{Z}(m)_{x_{k-1}^{n}, x_{k}^{n}}^{1}|^{\theta} = \left(\frac{1}{2^{n}}\right)^{\theta-1} (2^{m})^{\theta-1} \sum_{l=1}^{2^{m}} |\Delta_{l}^{m} Z|^{\theta}.$$
(3.17)

It is interesting to notice that

$$\Delta_l^m Z = \Delta_{2l}^{m+1} Z + \Delta_{2l-1}^{m+1} Z,$$

which gives

$$(2^{m})^{\theta-1} \sum_{l=1}^{2^{m}} |\Delta_{l}^{m} Z|^{\theta}$$

$$= (2^{m+1})^{\theta-1} \sum_{l=1}^{2^{m}} \left(\frac{1}{2}\right)^{\theta-1} |\Delta_{2l}^{m+1} Z + \Delta_{2l-1}^{m+1} Z|^{\theta}$$

$$\leq (2^{m+1})^{\theta-1} \sum_{l=1}^{2^{m}} \left(|\Delta_{2l}^{m+1} Z|^{\theta} + |\Delta_{2l-1}^{m+1} Z|^{\theta}\right)$$

$$= (2^{m+1})^{\theta-1} \sum_{l=1}^{2^{m+1}} |\Delta_{l}^{m+1} Z|^{\theta}. \tag{3.18}$$

This proves the claim.

As a consequence of Proposition 3.3, one can show that $\mathbf{Z}(m)_{x',x''}^1$ on any finite interval have finite θ -variations uniformly in m using a similar method in the proof of Proposition 4.3.1 in [24].

Proposition 3.4. For a continuous path Z_x satisfying (3.7) and $h\theta > 1$. Then $\mathbf{Z}(m)^1_{x',x''}$ have finite θ variation uniformly in m.

We present the convergence result of the first level path in the next theorem. Let $\mathbf{Z}_{a,b}^1 = Z_b - Z_a$. By (3.7), one can show that $E|\mathbf{Z}_{a,b}^1|^{\theta} \leq c\mathbf{w}_1(a,b)^{h\theta}$. In particular, $E|\mathbf{Z}_{x_{k-1},x_k}^1|^{\theta} \leq c\mathbf{w}_1(x_{k-1}^n,x_k^n)^{h\theta} \leq c(\frac{1}{2^n})^{h\theta}\mathbf{w}_1(x',x'')^{h\theta}$.

Theorem 3.5. For $h\theta > 1$, if a continuous path Z_x satisfying the inequality (3.7), then we have

$$\sum_{m=1}^{\infty} \sup_{D} \left(\sum_{l} |\mathbf{Z}(m)_{x_{l-1}, x_{l}}^{1} - \mathbf{Z}_{x_{l-1}, x_{l}}^{1}|^{\theta} \right)^{\frac{1}{\theta}} < \infty \quad a.s..$$
 (3.19)

In particular, $\mathbf{Z}(m)_{a,b}^1$ converges to $\mathbf{Z}_{a,b}^1$ in the θ -variation distance almost surely for any $(a,b) \in \Delta$.

Proof. For $n \leq m$, we have $\mathbf{Z}(m)_{x_{k-1}^n, x_k^n}^1 = \mathbf{Z}_{x_{k-1}^n, x_k^n}^1$, while if n > m then

$$|\mathbf{Z}(m)_{x_{k-1}^n, x_k^n}^1 - \mathbf{Z}_{x_{k-1}^n, x_k^n}^1|^{\theta} \le 2^{\theta - 1} \left(|\mathbf{Z}(m)_{x_{k-1}^n, x_k^n}^1|^{\theta} + |\mathbf{Z}_{x_{k-1}^n, x_k^n}^1|^{\theta} \right).$$

By (3.7) and Proposition 3.2, we have

$$E \sum_{m=1}^{\infty} \sup_{D} \left(\sum_{l} |\mathbf{Z}(m)_{x_{l-1},x_{l}}^{1} - \mathbf{Z}_{x_{l-1},x_{l}}^{1}|^{\theta} \right)^{\frac{1}{\theta}}$$

$$\leq C(\theta,\gamma) \sum_{m=1}^{\infty} \left(E \sum_{n=m+1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} |\mathbf{Z}(m)_{x_{k-1},x_{k}}^{1} - \mathbf{Z}_{x_{k-1},x_{k}}^{1}|^{\theta} \right)^{\frac{1}{\theta}}$$

$$\leq C \sum_{m=1}^{\infty} \left(E \sum_{n=m+1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} |\mathbf{Z}(m)_{x_{k-1},x_{k}}^{1}|^{\theta} + |\mathbf{Z}_{x_{k-1},x_{k}}^{1}|^{\theta} \right)^{\frac{1}{\theta}}$$

$$\leq C \sum_{m=1}^{\infty} \left(\sum_{n=m+1}^{\infty} n^{\gamma} \left(\frac{1}{2^{n}} \right)^{h\theta-1} \mathbf{w}_{1}(x', x'')^{h\theta} \right)^{\frac{1}{\theta}} \\
\leq C \sum_{m=1}^{\infty} \left(\frac{1}{2^{m}} \right)^{\frac{h\theta-1}{2\theta}} \sum_{n=m+1}^{\infty} n^{\frac{\gamma}{\theta}} \left(\frac{1}{2^{n}} \right)^{\frac{h\theta-1}{2\theta}} \\
\leq C \sum_{m=1}^{\infty} \left(\frac{1}{2^{m}} \right)^{\frac{h\theta-1}{2\theta}} \\
\leq \infty, \tag{3.20}$$

for $h\theta > 1$, where C is a generic constant depending on $\theta, h, \mathbf{w}_1(x', x'')$ and c in (3.7). This completes the proof.

3.2. Second level path

Next, we consider the convergence of second level path $\mathbf{Z}_{a,b}^2$. From [24], for $n \geq m$,

therefore,

$$= \frac{1}{2} \sum_{l=2^{m-n}(k-1)+1}^{2^{m-n}k} \left(\Delta_{2l-1}^{m+1} Z \otimes \Delta_{2l}^{m+1} Z - \Delta_{2l}^{m+1} Z \otimes \Delta_{2l-1}^{m+1} Z \right), \tag{3.23}$$

where $k = 1, ..., 2^{n}$.

We first give the result for the second level path $\mathbf{Z}(m)_{a,b}^2$ when $n \geq m$.

Proposition 3.6. For a continuous path Z_x which satisfies (3.7) with $h\theta > 1$, then for $n \ge m$

where C is a generic constant that depends on $\theta, h, \mathbf{w}_1(x', x'')$, and c in (3.7).

Proof. For $n \geq m$, it follows from (3.21)

$$= \sum_{l=1}^{2^{m+1}} \sum_{x_{l-1}^{m+1} \leq x_{k-1}^{n} < x_{l}^{m+1}} E \left| \frac{1}{2} 2^{2(m+1-n)} \left(\Delta_{l}^{m+1} Z \right)^{\otimes 2} - \frac{1}{2} 2^{2(m-n)} \left(\Delta_{l}^{m} Z \right)^{\otimes 2} \right|^{\frac{\theta}{2}}$$

$$= \sum_{l=1}^{2^{m+1}} 2^{n-m-1} E \left| \frac{1}{2} 2^{2(m+1-n)} \left(\Delta_{l}^{m+1} Z \right)^{\otimes 2} - \frac{1}{2} 2^{2(m-n)} \left(\Delta_{l}^{m} Z \right)^{\otimes 2} \right|^{\frac{\theta}{2}}$$

$$\leq C \left(\frac{2^{m}}{2^{n}} \right)^{\theta} \sum_{l=1}^{2^{m+1}} 2^{n-m-1} \left(\frac{1}{2^{m}} \right)^{h\theta} \mathbf{w}_{1}(x', x'')^{h\theta}$$

$$\leq C \left(\frac{2^{m}}{2^{n}} \right)^{\theta-h\theta} \left(\frac{1}{2^{n}} \right)^{h\theta-1}$$

$$\leq C \left(\frac{2^{m}}{2^{n}} \right)^{\theta-h\theta} \left(\frac{1}{2^{n}} \right)^{\frac{h\theta-1}{2}} \left(\frac{1}{2^{m}} \right)^{\frac{h\theta-1}{2}}$$

$$\leq C \left(\frac{1}{2^{m+n}} \right)^{\frac{h\theta-1}{2}}, \tag{3.25}$$

where C is a generic constant depending on $\theta, h, \mathbf{w}_1(x', x'')$, and c in (3.7).

The proof of the above result in the case when n < m is more involved as suggested by (3.23). In order to establish the convergence of the second level paths, it is crucial to estimate $\sum_{i} E(L_t^{x_{i+1}} - L_t^{x_i})(L_t^{x_{j+1}} - L_t^{x_j})$,

and to obtain the correct order in terms of the increments $x_{j+1} - x_j$ as suggested in [13]. This point will be made clear through the proof of the convergence of the second level path.

First, define

for the Gaussian case which is purely based on the concavity and monotonicity of σ^2 . As the function $|.|^{\alpha-1}$ for $\frac{3}{2} < \alpha < 2$ is both concave and monotone, therefore, the inequality (3.28) is also applicable for the local time of stable process. Hence, by (3.3) and (3.28), it follows that

where C_1 is a constant related to the constant c in (3.3). Now we are in the position to prove the following proposition

Proposition 3.7. Let $\frac{2}{3-\alpha} \le q < 3$, $2 \le \theta < 3$. Then for n < m

$$\begin{split} E \Big| \mathbf{Z}(m+1)_{x_{k-1}^n, x_k^n}^2 - \mathbf{Z}(m)_{x_{k-1}^n, x_k^n}^2 \Big|^2 \\ &= \frac{1}{4} E \Big| \sum_{l=2^{m-n}(k-1)+1}^{2^{m-n}k} \left(\Delta_{2l-1}^{m+1} Z \otimes \Delta_{2l}^{m+1} Z - \Delta_{2l}^{m+1} Z \otimes \Delta_{2l-1}^{m+1} Z \right) \Big|^2 \\ &= \frac{1}{4} \sum_{i,j=1, i \neq j}^2 \Big[E \sum_{l} \left(\Delta_{2l-1}^{m+1} Z^i \Delta_{2l}^{m+1} Z^j - \Delta_{2l}^{m+1} Z^i \Delta_{2l-1}^{m+1} Z^j \right)^2 \\ &\quad + 2E \sum_{r < l} \left(\Delta_{2l-1}^{m+1} Z^i \Delta_{2l}^{m+1} Z^j - \Delta_{2l}^{m+1} Z^i \Delta_{2l-1}^{m+1} Z^j \right) \\ &\quad \times \left(\Delta_{2r-1}^{m+1} Z^i \Delta_{2r}^{m+1} Z^j - \Delta_{2r}^{m+1} Z^i \Delta_{2r-1}^{m+1} Z^j \right) \Big] \\ &= \frac{1}{4} \sum_{l} E \Big[\left(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2l}^{m+1} g(x) \right)^2 - 2 \Delta_{2l-1}^{m+1} L_t^x \Delta_{2l}^{m+1} g(x) \Delta_{2l}^{m+1} L_t^x \Delta_{2l-1}^{m+1} g(x) \\ &\quad + \left(\Delta_{2l}^{m+1} L_t^x \Delta_{2l-1}^{m+1} L_t^x \right)^2 - 2 \Delta_{2l-1}^{m+1} L_t^x \Delta_{2l}^{m+1} g(x) \Delta_{2l-1}^{m+1} L_t^x \\ &\quad + \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2l-1}^{m+1} L_t^x \right)^2 \Big] \\ &+ \frac{1}{4} \sum_{l} E \Big[\left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2l}^{m+1} L_t^x \right)^2 - 2 \Delta_{2l-1}^{m+1} g(x) \Delta_{2l-1}^{m+1} L_t^x \Delta_{2l}^{m+1} g(x) \Delta_{2l-1}^{m+1} L_t^x \\ &\quad + \left(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \right) \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) \\ &\quad + E \Big(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \right) \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) \\ &\quad + E \Big(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \right) \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) \\ &\quad - \frac{1}{2} \sum_{r < l} \left(\left(\Delta_{2l}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) E \Big(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \right) \\ &\quad + \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) E \Big(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \right) \\ &\quad + \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) E \Big(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \right) \\ &\quad + \left(\Delta_{2l-1}^{m+1} g(x) \Delta_{2r-1}^{m+1} g(x) \right) E \Big(\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x \Big) \Big). \end{aligned}$$

\leq \sum_{l=2^{m-n} k}^{2^{m-n} k} C\left(\frac{1}{2^{m+1}} \right)^h \omega_1(x', x'')^h \sum_{r=1}^{l-1} \left(\frac{1}{2^{m+1}} \right)^h \omega_1(x', x'')^h E\left(|\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x | \right) \\
\leq C \sum_{l} \left(\frac{1}{2^{m+1}} \right)^{2h} \sum_{r} E\left(|\Delta_{2l-1}^{m+1} L_t^x \Delta_{2r-1}^{m+1} L_t^x | \right) \\
\leq C \sum_{l} \left(\frac{1}{2^{m+1}} \right)^{2h} |x_{2l-1}^{m+1} - x_{2l-2}^{m+1} |^{\alpha-1} \\
\leq C \left[2^{m-n} \left(\frac{1}{2^{m+1}} \right)^{2h+\alpha-1} \right] \\
= C \left[\frac{1}{2^n} \left(\frac{1}{2^m} \right)^{2h+\alpha-2} \right]. \tag{3.31}$$

The other terms can be estimated similarly. It then follows from Jesen's inequality that

By Propositions 3.6 and 3.7, we showed the convergence of the second level path. The convergence result is presented in the next theorem. As $\theta > \max\{p,q\}$, where $p > \frac{2}{\alpha-1}$ and $q \geq \frac{2}{3-\alpha}$ is the variation of the local time associated with the symmetric stable process and of the function g respectively, together with the fact that $\frac{2}{3-\alpha} < \frac{2}{\alpha-1}$ holds as long as $\alpha < 2$, therefore, the smallest possible value that α can take must satisfy $\alpha > \frac{2}{\theta} + 1$. As θ can be chosen very close to 3, hence, the smallest possible value of α that we can

satisfy $\alpha > \frac{2}{\theta} + 1$. As θ can be chosen very close to 3, hence, the smallest possible value of α that we can take for the second level path is $\alpha > \frac{5}{3}$. This means for any $\alpha \in (\frac{5}{3}, 2)$, there exists a $\theta \in (2, 3)$ such that $\alpha > \frac{2}{\theta} + 1$.

Theorem 3.8. Let $\frac{5}{3} < \alpha < 2$, $\frac{2}{3-\alpha} \le q < 3$. Then for a continuous path Z_x satisfing (3.7), there exists a unique \mathbf{Z}^2 on the simplex \triangle taking values in $\mathbb{R}^2 \otimes \mathbb{R}^2$ such that

$$\sup_{D} \left(\sum_{l} \left| \mathbf{Z}(m)_{x_{l-1}, x_{l}}^{2} - \mathbf{Z}_{x_{l-1}, x_{l}}^{2} \right|^{\frac{\theta}{2}} \right)^{\frac{2}{\theta}} \to 0, \tag{3.33}$$

both almost surely and in $L^1(\Omega, \mathcal{F}, \mathcal{P})$ as $m \to \infty$, for some θ such that $\frac{4}{2h+\alpha-1} < \theta < 3$.

Proof. By Proposition 4.1.2 in [24], we have

$$\times \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} |\mathbf{Z}(m+1)_{x_{k-1},x_{k}}^{1}|^{\theta} + |\mathbf{Z}(m)_{x_{k-1},x_{k}}^{1}|^{\theta}\right)^{\frac{1}{2}}$$

$$+ C(\theta,\gamma) E\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} |\mathbf{Z}(m+1)_{x_{k-1},x_{k}}^{2} - \mathbf{Z}(m)_{x_{k-1},x_{k}}^{2}|^{\frac{\theta}{2}}$$

$$:= A + B. \tag{3.34}$$

We have proved the convergence of the first level path in Theorem 3.5. The result from Theorem 3.5 is used to estimate the part A, that is

$$A \leq C \left(E \sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1} - \mathbf{Z}_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} + \left| \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1} - \mathbf{Z}_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} \right)^{\frac{1}{2}}$$

$$\times \left(E \sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} + \left| \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} \right)^{\frac{1}{2}}$$

$$\leq C \left[\left(\frac{1}{2^{m}} \right)^{\frac{h\theta-1}{4}} \left(\sum_{n=1}^{\infty} n^{\gamma} \left(\frac{1}{2^{n}} \right)^{h\theta-1} \right)^{\frac{1}{2}} \right]$$

$$\leq C \left(\frac{1}{2^{m}} \right)^{\frac{h\theta-1}{4}} .$$

$$(3.35)$$

For $\frac{5}{3} < \alpha < 2$ and $h > \frac{1}{3}$, we can choose θ satisfies $\frac{4}{2h+\alpha-1} < \theta < 3$. Therefore, $\frac{2h+\alpha-2}{4}\theta > 1 - \frac{\theta}{4}$. Hence, we can choose an ϵ such that $1 - \frac{\theta}{4} < \epsilon < \frac{2h+\alpha-2}{4}\theta$. Then by Proposition 3.6 and 3.7, it follows that

If we sum up for all m as we did in Theorem 3.5, one can show that $(\mathbf{Z}(m)^2)_{m\in N} \in (\mathbb{R}^2)^{\otimes 2}$ is a Cauchy sequence in θ -variation distance. In other words, it has a limit as $m \to \infty$, denote it by $\mathbf{Z}^2 \in (\mathbb{R}^2)^{\otimes 2}$. By Lemma 3.3.3 in [24], we can conclude that \mathbf{Z}^2 is also finite under θ -variation distance. Thus, we have proved the theorem.

As local time L_t^x has a compact support for each ω and t, so the integral of local time in \mathbb{R} can be defined. We take [x', x''] which contains the support of L_t^x . By Chen's identity, one can see that for any $(a, b) \in \Delta$,

$$(\mathbf{Z}_{a,b}^{2})_{2,1} = \lim_{m(D_{[a,b]})\to 0} \sum_{i=0}^{r-1} ((\mathbf{Z}_{x_{i-1},x_{i}}^{2})_{2,1} + (\mathbf{Z}_{a,x_{i}}^{1} \otimes \mathbf{Z}_{x_{i-1},x_{i}}^{1})_{2,1})$$

$$= \lim_{m(D_{[a,b]})\to 0} \sum_{i=0}^{r-1} ((\mathbf{Z}_{x_{i-1},x_{i}}^{2})_{2,1} + (g(x_{i}) - g(a))(L_{t}^{x_{i}} - L_{t}^{x_{i-1}}). \tag{3.37}$$

Here $(\mathbf{Z}^2_{x_{i-1},x_i})_{2,1}$ denotes the lower-left element of the 2×2 matrix $\mathbf{Z}^2_{x_{i-1},x_i}$. Hence, the following

$$= \lim_{m(D_{[a,b]})\to 0} \sum_{i=0}^{r-1} ((\mathbf{Z}_{x_{i-1},x_i}^2)_{2,1} + (g(x_i) - g(a))(L_t^{x_i} - L_t^{x_{i-1}})) + g(a)(L_t^b - L_t^a)$$
(3.38)

holds. Therefore, we have the following corollary.

Corollary 3.9. Under the same conditions of the previous theorem, then for $(a,b) \in \Delta$,

$$\int_{a}^{b} L_{t}^{x} dL_{t}^{x} = \lim_{m(D_{[a,b]}) \to 0} \sum_{i=0}^{r-1} ((\mathbf{Z}_{x_{i-1},x_{i}}^{2})_{1,1} + L_{t}^{x_{i}} (L_{t}^{x_{i}} - L_{t}^{x_{i-1}})). \tag{3.39}$$

Moreover, if g is a continuous function with bounded q-variation, $q \geq \frac{2}{3-\alpha}$, then we have

$$\int_{a}^{b} g(x)dL_{t}^{x} = \lim_{m(D_{[a,b]})\to 0} \sum_{i=0}^{r-1} ((\mathbf{Z}_{x_{i-1},x_{i}}^{2})_{2,1} + g(x_{i})(L_{t}^{x_{i}} - L_{t}^{x_{i-1}})).$$
(3.40)

3.3. Convergence of rough path integrals for the second level path

In this section, we will prove the convergence of the second level path in the θ -variation topology.

Proposition 3.10. Let $\frac{5}{3} < \alpha < 2$, $\frac{2}{3-\alpha} \le q < 3$, one can choose a θ such that $\frac{4}{2h+\alpha-1} < \theta < 3$. Moreover, let $Z_j(x) := (L_t^x, g_j(x)), Z(x) := (L_t^x, g(x)),$ where $g_j(\cdot), g(\cdot)$ are both continuous and of bounded q-variation. Suppose $g_j(x) \to g(x)$ as $j \to \infty$ uniformly and the control function $\mathbf{w}_j(x,y)$ of g_j converges to the control function $\mathbf{w}(x,y)$ of g as $j \to \infty$ uniformly. Then the geometric rough path $\mathbf{Z}_j(\cdot)$ associated with $Z_j(\cdot)$ converges to the geometric rough path $\mathbf{Z}(\cdot)$ associated with $Z(\cdot)$ a.s. in the θ -variation topology as $j \to \infty$. In particular, $\int_{-\infty}^{\infty} g_j(x) dL_t^x \to \int_{-\infty}^{\infty} g(x) dL_t^x$ a.s. as $j \to \infty$.

Proof. For each j, one can obtain the geometric rough path $\mathbf{Z}_j(\cdot)$ associated with $Z_j(\cdot)$, and also the smooth rough path $\mathbf{Z}_j(m)$ in the same way as $\mathbf{Z}(m)$. Here the \mathbf{Z}_j is defined as $\mathbf{Z}_j = (1, \mathbf{Z}_j^1, \mathbf{Z}_j^2)$. Similarly, we have $\mathbf{Z}_j(m) = (1, \mathbf{Z}_j^1(m), \mathbf{Z}_j^2(m))$. First, we prove the convergence of $\mathbf{Z}_j^1 \to \mathbf{Z}^1$ in the θ -variation topology and in the uniform topology. To see this, we consider for any finite interval [x', x''] in \mathbb{R} . As local time L_t^x has a compact support in x a.s., so the following proof can be extended to \mathbb{R} . To prove that $\mathbf{Z}_j^1 \to \mathbf{Z}^1$ as $j \to \infty$ in the $d_{2,\theta}$ topology, note first

$$d_{2,\theta}(\mathbf{Z}_{i}^{1}, \mathbf{Z}^{1}) \leq d_{2,\theta}(\mathbf{Z}_{i}^{1}, \mathbf{Z}_{i}^{1}(m)) + d_{2,\theta}(\mathbf{Z}_{i}^{1}(m), \mathbf{Z}^{1}(m)) + d_{2,\theta}(\mathbf{Z}^{1}(m), \mathbf{Z}^{1}). \tag{3.41}$$

From (3.20), we know that $d_{2,\theta}(\mathbf{Z}^1(m), \mathbf{Z}^1) \to 0$ as $m \to \infty$ and $d_{2,\theta}(\mathbf{Z}^1_j, \mathbf{Z}^1_j(m)) \to 0$ as $m \to \infty$ uniformly in j. Thus there exists an integer m_0 such that $d_{2,\theta}(\mathbf{Z}^1(m_0), \mathbf{Z}^1) < \frac{\epsilon}{3}$ and $d_{2,\theta}(\mathbf{Z}^1_j, \mathbf{Z}^1_j(m_0)) < \frac{\epsilon}{3}$. Consider $\mathbf{Z}^1_j(m_0)$ and $\mathbf{Z}^1(m_0)$, which are bounded variation processes and $\mathbf{Z}^1_j(m_0)(x) \to \mathbf{Z}^1(m_0)(x)$ as $j \to \infty$ uniformly in x. Moreover,

$$E \sup_{D} \sum_{l} \left| \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l}) - \mathbf{Z}^{1}(m_{0})(x_{l}) \right) - \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l-1}) - \mathbf{Z}^{1}(m_{0})(x_{l-1}) \right) \right|^{2}$$
(3.42)

exists and bounded uniformly in j. Thus, by Fatou's Lemma, we have

$$\limsup_{j \to \infty} E \sup_{D} \sum_{l} \left| \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l}) - \mathbf{Z}^{1}(m_{0})(x_{l}) \right) - \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l-1}) - \mathbf{Z}^{1}(m_{0})(x_{l-1}) \right) \right|^{2} \\
\leq E \lim_{j \to \infty} \sup_{D_{[a,b]}} \sum_{l} \left| \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l}) - \mathbf{Z}^{1}(m_{0})(x_{l}) \right) - \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l-1}) - \mathbf{Z}^{1}(m_{0})(x_{l-1}) \right) \right|^{2} \\
= E \sup_{D_{[a,b]}} \sum_{l} \lim_{j \to \infty} \left| \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l}) - \mathbf{Z}^{1}(m_{0})(x_{l}) \right) - \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l-1}) - \mathbf{Z}^{1}(m_{0})(x_{l-1}) \right) \right|^{2} \\
= 0.$$

The exchange of $\lim_{i\to\infty}$ and $\sup_{i\to\infty}$ is due to the fact that

$$\lim_{j \to \infty} \sum_{l} \left| \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l}) - \mathbf{Z}^{1}(m_{0})(x_{l}) \right) - \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l-1}) - \mathbf{Z}^{1}(m_{0})(x_{l-1}) \right) \right|^{2} = 0$$

uniformly with the partition $D_{[a,b]}$. Thus, we revisit (3.41) and apply $m=m_0$ to conclude there exists J_0 such that when $j \geq J_0$

$$d_{2,\theta}\left(\mathbf{Z}_{j}^{1},\mathbf{Z}^{1}\right)<\epsilon.$$

Thus,

$$\limsup_{j \to \infty} E \sup_{D} \sum_{l} \left| \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l}) - \mathbf{Z}^{1}(m_{0})(x_{l}) \right) - \left(\mathbf{Z}_{j}^{1}(m_{0})(x_{l-1}) - \mathbf{Z}^{1}(m_{0})(x_{l-1}) \right) \right|^{2} = 0.$$

For the convergence of $\mathbf{Z}_i^2 \to \mathbf{Z}^2$, similarly, we have

$$d_{2,\theta}(\mathbf{Z}_{j}^{2}, \mathbf{Z}^{2}) \leq d_{2,\theta}(\mathbf{Z}_{j}^{2}, \mathbf{Z}_{j}^{2}(m)) + d_{2,\theta}(\mathbf{Z}_{j}^{2}(m), \mathbf{Z}^{2}(m)) + d_{2,\theta}(\mathbf{Z}^{2}(m), \mathbf{Z}^{2}). \tag{3.43}$$

The convergence of the last term of (3.43) as $m \to \infty$ is clear from Theorem 3.8. From the proofs of Proposition 3.6, 3.7 and Theorem 3.8, one can show the convergence of the first term of (3.43) uniformly in j as $m \to \infty$. That is to say, for any given $\epsilon > 0$, one can find a N such that for $m \ge N$, $d_{2,\theta}(\mathbf{Z}_j^2,\mathbf{Z}_j^2(m)) < \frac{\epsilon}{3}$ for all j, and $d_{2,\theta}(\mathbf{Z}^2(m),\mathbf{Z}^2) < \frac{\epsilon}{3}$. In particular, the above inequality also holds if we replace m by N. For a fixed partition of [x',x''] and this N, one can show by the same method as in the proof of $d_{2,\theta}(\mathbf{Z}_j^1(m_0),\mathbf{Z}^1(m_0))$ as $j \to \infty$ that $d_{2,\theta}(\mathbf{Z}_j^2(N),\mathbf{Z}^2(N)) < \frac{\epsilon}{3}$ by the bounded variation property of the smooth rough path. This can be seen as $\mathbf{Z}_j^2(N)$ and $\mathbf{Z}^2(N)$ are just tensor product of bounded variation paths $\mathbf{Z}_j(N)$ and $\mathbf{Z}(N)$. Thus $\mathbf{Z}_j^2(N)(x)$ also converge to $\mathbf{Z}^2(N)(x)$ uniformly in x. By using a similar method as in the proof $d_{2,\theta}(\mathbf{Z}_j^1(m),\mathbf{Z}^1(m)) \to 0$ as $j \to \infty$, we can prove that $d_{2,\theta}(\mathbf{Z}_j^2(N),\mathbf{Z}^2(N)) \to 0$ as $j \to \infty$ so there exists an integer J > 0 such that $j \ge J$, $d_{2,\theta}(\mathbf{Z}_j^2(N),\mathbf{Z}^2(N)) < \frac{\epsilon}{3}$. Hence, for $j \ge J$, it follows from (3.43) for m = N that $d_{2,\theta}(\mathbf{Z}_j^2,\mathbf{Z}^2) \le \epsilon$. The first claim is asserted. By the definition of $\int_{-\infty}^{\infty} g_j(x) dL_t^x$, one can conclude the second claim.

Proposition 3.10 is also true for g being of bounded q-variation $(\frac{2}{3-\alpha} \le q < 3)$ but not being continuous. For the discontinuous case, we use the method from [36] by adding a fictitious space interval during which linear segments remove the discontinuity, also bear in mind that a function with bounded q-variation has at most countable jumps.

Definition 3.11. Let g(x) is càdlàg in x of finite q-variation and set $G(x) := (g(x), L_t(x))$. Let $\delta > 0$, for each $n \geq 1$, let x_n be the point of the n-th largest jump of g. Define a map

$$\tau_{\delta}: [x', x''] \to [x', x'' + \delta \sum_{n=1}^{\infty} |h(x_n)|^q]$$

in the following way

$$\tau_{\delta}(x) = x + \delta \sum_{n=1}^{\infty} |h(x_n)|^q 1_{x_n \le x}(x),$$

where $h(x_n) := G(x_n) - G(x_n)$. The map $\tau_{\delta} : [x', x''] \to [x', \tau_{\delta}(x'')]$ extends the space interval into one where we define the continuous path $G_{\delta}(y)$ from a càdlàg path G by

$$G_{\delta}(y) = \begin{cases} G(x), & \text{if } y = \tau_{\delta}(x); \\ G(x_n -) + (y - \tau_{\delta}(x_n -))h(x_n)\delta^{-1}|h(x_n)|^{-q}, & \text{if } y \in [\tau_{\delta}(x_n -), \tau_{\delta}(x_n)). \end{cases}$$

Notice that $L_{t,\delta}(y) := L_{t,\delta}(\tau_{\delta}(x)) = L_t^x$ as L_t^x is continuous. Let g(x) be a càdlàg path with bounded q-variation $(\frac{2}{3-\alpha} \le q < 3)$, we define

$$\int_{x'}^{x''} L_t^x dg(x) = \int_{x'}^{x''} L_t^x dg^c(x) + \sum_r L_t^{x_r} (h(x_r) - h(x_r)), \tag{3.44}$$

where the discontinuous g is decomposed into its continuous part g^c and its jump part h.

Theorem 3.12. Let g(x) be a càdlàg path with bounded q-variation $(\frac{2}{3-\alpha} \le q < 3)$. Then

$$\int_{x'}^{x''} L_t^x dg(x) = \int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dg_{\delta}(y). \tag{3.45}$$

Proof. The right hand side of (3.45) is a rough path as defined in the previous section. As local time is continuous, hence the integral $\int_{x'}^{x''} L_t^x dg^c(x)$ is a rough path can be defined as in the previous section. For the integral associated with the jump part, we need the method pointed out before the theorem. At each discontinuous point x_r

$$\int_{x_r-}^{x_r} L_t^x dg(x) = L_t(x_r)(g(x_r) - g(x_r-)) = L_t(x_r)(h(x_r) - h(x_r-)).$$

By Definition 3.11, we have that

$$L_t(x_r)(g(x_r) - g(x_r)) = L_{t,\delta}(\tau_{\delta}(x_r))(g_{\delta}(\tau_{\delta}(x_r)) - g_{\delta}(\tau_{\delta}(x_r))).$$

Hence, it follows that

$$\sum_{x} L_{t}(x_{r})(g(x_{r}) - g(x_{r} - 1)) = \sum_{x} L_{t,\delta}(\tau_{\delta}(x_{r} - 1))(g_{\delta}(\tau_{\delta}(x_{r})) - g_{\delta}(\tau_{\delta}(x_{r} - 1))).$$
(3.46)

From Corollary 3.9, we know that the right hand side of (3.46) alone is not well defined, but together with $\sum_{r}((\mathbf{Z})_{1,2}^2)$ it is well defined. In this case, we need to check that

$$\sum_{r} ((\mathbf{Z}_{\delta})^2_{\tau_{\delta}(x_r-),\tau_{\delta}(x_r)})_{1,2} = 0$$

in order to have (3.46) to be well defined. From Corollary 3.9 and the continuity of local time, we obtain that

$$\sum_{r} ((\mathbf{Z}_{\delta})^{2}_{\tau_{\delta}(x_{r}-),\tau_{\delta}(x_{r})})_{1,2} = \sum_{r} \int_{\tau_{\delta}(x_{r}-)}^{\tau_{\delta}(x_{r})} (L_{t,\delta}(y) - L_{t,\delta}(\tau_{\delta}(x_{r}-))) dg_{\delta}(y) = 0,$$

where $Z_{\delta}(y) := (L_{t,\delta}(y), g_{\delta}(y))$. Therefore, we have

$$\sum_{r} \int_{x_{r}-}^{x_{r}} L_{t}^{x} dh(x) = \sum_{r} \int_{\tau_{\delta}(x_{r}-)}^{\tau_{\delta}(x_{r})} L_{t}^{\delta}(y) dg_{\delta}(y) = \sum_{r} \int_{\tau_{\delta}(x_{r}-)}^{\tau_{\delta}(x_{r})} L_{t}^{\delta}(y) dh_{\delta}(y).$$

As the continuous part g^c is the same as g_{δ} on the space interval where g is continuous and g^c does not contribute on the interval where the function jump. Simimlary, where g is jump discontinuous, we denote as h, does not contribute on the interval where the function is continuous, hence

$$\int_{x'}^{x''} L_t^x dg(x) = \int_{x'}^{x''} L_t^x dg^c(x) + \int_{x'}^{x''} L_t^x dh(x)
= \int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dg^c_{\delta}(y) + \int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dh_{\delta}(y)
= \int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dg_{\delta}(y).$$

This completes the proof.

The convergence for discontinuous functions can be proved by applying the method in the above theorem and Proposition 3.10 to (h-g)(x). Note the function h_{δ} is piecewise linear for fixed $\delta > 0$. It is certainly of bounded q-variation with a control function \mathbf{w}_{δ} . If $h_{\delta j}$ is a sequence of bounded q-variation functions with control function $\mathbf{w}_{\delta j}$ such that $h_{\delta j} \to h_{\delta}$ and $\mathbf{w}_{\delta j} \to \mathbf{w}_{\delta}$ as $j \to \infty$ uniformly. Then, we have

$$\int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dh_{\delta j}(y) \to \int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dh_{\delta}(y)$$

as $j \to \infty$. Hence, we have the following proposition.

Proposition 3.13. Let $\alpha \in (\frac{5}{3}, 2)$, $\frac{2}{3-\alpha} \leq q < 3$, θ be chosen such that $\frac{4}{2h+\alpha-1} < \theta < 3$. Consider h, the jump part of the function g and assume there is a sequence of continuous functions $h_j \to h$ as $j \to \infty$. Let $h_{j\delta}$ and h_{δ} be defined in the same way as $G_{\delta}(y)$. Let $h_{\delta j}$ be a sequence of continuous function satisfying $h_{\delta j} \to h_{\delta}$ as $j \to \infty$ together with their control functions and

$$\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{j\delta}(y) = \int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta j}(y). \tag{3.47}$$

Then as $j \to \infty$

$$\int_{-\infty}^{\infty} L_t^x dh_j(x) \to \int_{-\infty}^{\infty} L_t^x dh(x).$$

Proof. By Theorem 3.12, integration by parts formula and assumption (3.47), one can see that

$$\int_{-\infty}^{\infty} h_j(x) dL_t^x = \int_{-\infty}^{\infty} h_{j\delta}(y) dL_t^{\delta}(y)$$
$$= -\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{j\delta}(y)$$
$$= -\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta j}(y).$$

By the assumption that $h_{\delta j} \to h_{\delta}$ as $j \to \infty$ together with their control functions, then by Proposition 3.10 we have $\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta j}(y) \to \int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta}(y)$. By using Theorem 3.12, we have that $\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta}(y) = \int_{-\infty}^{\infty} L_t^x dh(x)$. Hence, the result of the proposition follows.

Corollary 3.14. Let $\alpha \in (\frac{5}{3}, 2)$, $\frac{2}{3-\alpha} \le q < 3$, θ be chosen such that $\frac{4}{2h+\alpha-1} < \theta < 3$. Moreover, let $Z_j(x) := (L_t^x, g_j(x)), Z(x) := (L_t^x, g_j(x)), where <math>g_j(.), g(.)$ are both of bounded q-variation, and g_j is continuous and g_j is continuous and g_j is continuous and g_j is continuous $g_j = g_j + g_j + g_j$ with control function \mathbf{w}_{cj} and \mathbf{w}_{hj} such that $g_{cj} \to g_c$ and $\mathbf{w}_{cj} \to \mathbf{w}_c$ uniformly, $g_j = g_j + g_j + g_j$ and $g_j = g_j + g_j + g_j + g_j$ and $g_j = g_j + g_j +$

$$\int_{-\infty}^{\infty} g_j(x) dL_t^x \to \int_{-\infty}^{\infty} g(x) dL_t^x \quad a.s. \quad as \quad j \to \infty.$$

Proof. The Corollary follows from Theorem 3.12 and Proposition 3.13.

3.4. Third level rough path

The θ -variation formula for third level path in [24] is given as

$$\sup_{D} \left| \mathbf{Z}(m+1)_{x_{l-1},x_{l}}^{3} - \mathbf{Z}(m)_{x_{l-1},x_{l}}^{3} \right|^{\frac{\theta}{3}} \\
\leq C_{2} \sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{3} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{3} \right|^{\frac{\theta}{3}} \\
+ C_{3} \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} \right)^{\frac{1}{3}} \\
\times \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{2} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{2} \right|^{\frac{\theta}{2}} \right)^{\frac{1}{3}} \\
+ C_{4} \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{2} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{2} \right|^{\frac{\theta}{2}} \right)^{\frac{2}{3}} \\
\times \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} + \left| \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} \right)^{\frac{1}{3}} \\
+ C_{5} \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} \right)^{\frac{1}{3}} \\
\times \left(\sum_{n=1}^{\infty} n^{\gamma} \sum_{k=1}^{2^{n}} \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1} \right|^{\theta} \right)^{\frac{1}{3}} \right.$$
(3.48)

where $\{x_k^n\}$ satisfing (3.9).

We have obtained estimations for the first and second level paths. As there is a connection between the sample path of local time of symmetric stable processes and its associated Gaussian processes by Dynkin isomorphism theorem (cf. [25]), therefore, we present some relevant results for the Gaussian processes first. The importance of the following result regarding Gaussian random variables will be made clear throughout the estimation of the θ -variation on the third level path.

Again, we have

$$|g(b) - g(a)|^2 \le \mathbf{w}_1(a, b)^{2h}$$
 (3.49)

for any $(a, b) \in \Delta$ and $h\theta > 1$.

We consider the cross product term on the increments of the g with parameter h. By a purely algebraic procedure as in (3.27), for b > a, $\varrho > 0$, we have

$$\left(g(b) - g(a)\right) \left(g(b+\varrho) - g(a+\varrho)\right) \leq \frac{1}{2} \left(\mathbf{w}_1(b+\varrho,a)^{2h} - \mathbf{w}_1(b+\varrho,b)^{2h} + \mathbf{w}_1(a+\varrho,b)^{2h} - \mathbf{w}_1(a+\varrho,a)^{2h}\right).$$
(3.50)

All the estimations of the variance or covariance of the local time one encounter later in this paper are similar to one of the following formats. For $m \leq n$, the proof on the convergence of the third level path is a straightforward exercise as pointed out in the proof of the Proposition 4.5.1 in [24]. For m > n, $k = 1, 2, \ldots, 2^n, 2^{m-n}(k-1) + 1 \leq r < l \leq 2^{m-n}k$, the estimations of the variance of local time on different intervals are given by

$$\begin{split} & \sum_{k=1}^{2^{n}} E \left| \mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{3} - \mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{3} \right|^{\frac{\theta}{3}} \\ & \leq C \left[\left(\frac{1}{2^{n}} \right)^{\frac{1+2h}{6}\theta - 1} \left(\frac{1}{2^{m}} \right)^{\frac{2h+\alpha-2}{6}\theta} + \left(\frac{1}{2^{n}} \right)^{\frac{\alpha}{6}\theta - 1} \left(\frac{1}{2^{m}} \right)^{\frac{2h+\alpha-2}{6}\theta} + \left(\frac{1}{2^{n}} \right)^{\frac{1}{6}\theta - 1} \left(\frac{1}{2^{m}} \right)^{\frac{2h+2\alpha-3}{6}\theta} \\ & + \left(\frac{1}{2^{n}} \right)^{\frac{\theta}{6} - 1} \left(\frac{1}{2^{m}} \right)^{\frac{4h+\alpha-2}{6}\theta} + \left(\frac{1}{2^{n}} \right)^{\frac{\theta}{6} - 1} \left(\frac{1}{2^{m}} \right)^{\frac{\theta}{6} - 1} \left(\frac{1}{2^{m}} \right)^{\frac{3\alpha-5}{6}\theta} \right], \end{split} \tag{3.105}$$

where C is a generic constant depends on θ , h, $\mathbf{w}_1(x', x'')$, and c in (3.7).

Theorem 3.19. Let $\alpha \in (\frac{3}{2}, 2)$, $\frac{2}{3-\alpha} \leq q < 4$. Then for a continuous path Z_x satisfy (3.7), there exists a unique \mathbf{Z}^3 and a simplex Δ taking values in $(\mathbb{R}^2)^{\otimes 3}$ such that

$$\sup_{D} \left(\sum_{l} \left| \mathbf{Z}(m)_{x_{l-1}, x_{l}}^{3} - \mathbf{Z}_{x_{l-1}, x_{l}}^{3} \right|^{\frac{\theta}{3}} \right)^{\frac{3}{\theta}} \to 0, \tag{3.106}$$

both almost surely and in $L^1(\Omega, \mathcal{F}, \mathcal{P})$ as $m \to \infty$, for some θ such that $\frac{4}{2h+\alpha-1} < \theta < 4$.

Proof. From [24], we have

$$+C_{4}E\left(\sum_{n=1}^{\infty}n^{\gamma}\sum_{k=1}^{2^{n}}\left|\mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{2}-\mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{2}\right|^{\frac{\theta}{2}}\right)^{\frac{2}{3}}$$

$$\times\left(\sum_{n=1}^{\infty}n^{\gamma}\sum_{k=1}^{2^{n}}\left|\mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1}\right|^{\theta}+\left|\mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1}\right|^{\theta}\right)^{\frac{1}{3}}$$

$$+C_{5}E\left(\sum_{n=1}^{\infty}n^{\gamma}\sum_{k=1}^{2^{n}}\left|\mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1}-\mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1}\right|^{\theta}\right)^{\frac{1}{3}}$$

$$\times\left(\sum_{n=1}^{\infty}n^{\gamma}\sum_{k=1}^{2^{n}}\left|\mathbf{Z}(m+1)_{x_{k-1},x_{k}^{n}}^{1}\right|^{\theta}+\left|\mathbf{Z}(m)_{x_{k-1},x_{k}^{n}}^{1}\right|^{\theta}\right)^{\frac{2}{3}}.$$

By Propositions 3.15 and 3.18, the estimate of the first term on the r.h.s. of (3.107) is

For $h > \frac{1}{4}$ and $\alpha > \frac{3}{2}$, one can choose θ sufficiently close to 4 such that $\frac{2h+1}{6}\theta - 1 > 0$, $\frac{2h+\alpha-2}{6}\theta > 0$, $\frac{\alpha}{6}\theta - 1 > 0$, $\frac{2\theta}{6} - 1 > 0$, $\frac{4\alpha-6}{6}\theta > 0$. We choose $\epsilon > 0$ with $\frac{2}{3} - \frac{\theta}{6} < \epsilon < min\{\frac{2h+2\alpha-3}{6}\theta - \frac{1}{3}, \frac{4h+\alpha-2}{6}\theta - \frac{1}{3}, \frac{6h-1}{6}\theta - \frac{1}{3}\} = \frac{6h-1}{6}\theta - \frac{1}{3}$, hence

Therefore, if we sum up all m, we would have $\sum_{m} K_m < \infty$. This shows that $(\mathbf{Z}(m)^3)_{m \in \mathbb{N}} \in (\mathbb{R}^2)^{\otimes 3}$ is a

Cauchy sequence in θ -variation distance. In other words, it has a limit as $m \to \infty$, denote it by $\mathbf{Z}^3 \in (\mathbb{R}^2)^{\otimes 3}$. By Lemma 3.3.3 in [24], \mathbf{Z}^3 has finte θ -variation. Together with the convergence result of the second level path and first level path, we complete the proof of the theorem.

Based on Chapter 5 in [24], for any Lipschitz one form in the sense of Stein $\hat{f}: \mathbb{R}^2 \to L(\mathbb{R}^2, \mathbb{R}^2)$, the

almost rough path $Y = (1, Y_{a,b}^1, Y_{a,b}^2, Y_{a,b}^3)$ is given by

$$\begin{split} Y_{a,b}^1 &= \widehat{f}(\mathbf{Z}_a)\mathbf{Z}_{a,b}^1 + \widehat{f}^2(\mathbf{Z}_a)\mathbf{Z}_{a,b}^2 + \widehat{f}^3(\mathbf{Z}_a)\mathbf{Z}_{a,b}^3, \\ Y_{a,b}^2 &= (\widehat{f}(\mathbf{Z}_a) \otimes \widehat{f}(\mathbf{Z}_a))\mathbf{Z}_{a,b}^2 + (\widehat{f}(\mathbf{Z}_a) \otimes \widehat{f}^2(\mathbf{Z}_a)) \int_{s < u_1 < u_2 < t} d\mathbf{Z}_{s,u_1}^1 \otimes d\mathbf{Z}_{s,u_2}^2, \\ &+ (\widehat{f}^2(\mathbf{Z}_a) \otimes \widehat{f}(\mathbf{Z}_a)) \int_{s < u_1 < u_2 < t} d\mathbf{Z}_{s,u_1}^2 \otimes d\mathbf{Z}_{s,u_2}^1, \\ Y_{a,b}^3 &= (\widehat{f}(\mathbf{Z}_a) \otimes \widehat{f}(\mathbf{Z}_a) \otimes \widehat{f}(\mathbf{Z}_a))\mathbf{Z}_{a,b}^3. \end{split}$$

Consider one form $\widehat{f}: \mathbb{R}^2 \to L(\mathbb{R}^2, \mathbb{R}^2)$ defined as

$$\widehat{f}(z)\xi = (v, yv).$$

where z = (x, y) and $\xi = (v, w)$. For the general case, it is defined as

$$\widehat{f}^{k+1}(v,w)(\mathbf{v}) = \left(0, \sum_{j} d^{k} \widehat{f}(w)(w_{k+1}^{j}, \dots, w_{2}^{j}) v_{1}^{j}\right)$$

for all $\mathbf{v} = \sum_{j} (v_{k+1}^{j}, w_{k+1}^{j}) \otimes \cdots \otimes (v_{2}^{j}, w_{2}^{j}) \otimes (v_{1}^{j}, w_{1}^{j})$. We use the notation $\int_{a}^{b} \widehat{f}(\mathbf{Z}) d\mathbf{Z}^{n}$ to denote the n-th degree term of $\int_{a}^{b} \widehat{f}(\mathbf{Z}) d\mathbf{Z}$. When n = 1, we have

$$\int_{-\infty}^{\infty} \widehat{f}(\mathbf{Z}) d\mathbf{Z}^{1} = \left(\int_{-\infty}^{\infty} dL_{t}^{x}, \int_{-\infty}^{\infty} g(x) dL_{t}^{x} \right). \tag{3.109}$$

One can therefore use the almost rough path to construct the unique rough path $\int_{-\infty}^{\infty} \hat{f}(\mathbf{Z}) d\mathbf{Z}$ with roughness θ in $T^{(3)}(\mathbb{R}^2)$. In particular

$$\int_{-\infty}^{\infty} \widehat{f}(\mathbf{Z}) d\mathbf{Z}^{1}$$

$$= \lim_{m(D) \to 0} \sum_{i=1}^{r} Y_{x_{i-1}, x_{i}}^{1}$$

$$= \lim_{m(D) \to 0} \sum_{i=1}^{r} \left[\widehat{f}(\mathbf{Z}_{x_{i-1}}) (\mathbf{Z}_{x_{i-1}, x_{i}}^{1}) + \widehat{f}^{2}(\mathbf{Z}_{x_{i-1}}) (\mathbf{Z}_{x_{i-1}, x_{i}}^{2}) + \widehat{f}^{3}(\mathbf{Z}_{x_{i-1}}) (\mathbf{Z}_{x_{i-1}, x_{i}}^{3}) \right].$$
(3.110)

The above integral is well defined as the limit of the almost rough path. In particular, we have

$$\widehat{f}(\mathbf{Z}_a)(\mathbf{Z}_{a,b}^1) + \widehat{f}^2(\mathbf{Z}_a)(\mathbf{Z}_{a,b}^2) + \widehat{f}^3(\mathbf{Z}_a)(\mathbf{Z}_{a,b}^3) = \left(L_t^b - L_t^a, g(a)(L_t^b - L_t^a)\right) + \left(0, (\mathbf{Z}_{a,b}^2)_{2,1}\right)\right)$$

as \hat{f}^3 is equal to zero for this particular linear one-form. Hence, we have the following corollary.

Corollary 3.20. Let $\frac{3}{2} < \alpha < 2$ and g be a continuous function with bounded q-variation, $\frac{2}{3-\alpha} < q < 4$. Then, the integral $\int_a^b g(x)dL_t^x$ for $(a,b) \in \Delta$ can be defined as

$$\int_{a}^{b} g(x)dL_{t}^{x} = \lim_{m(D)\to 0} \left[\sum_{i=1}^{r} g(x_{i-1})(L_{t}^{x_{i}} - L_{t}^{x_{i-1}}) + (\mathbf{Z}_{x_{i-1},x_{i}}^{2})_{2,1} \right].$$

3.5. Convergence of rough path integrals for the third level path

In this section, we will prove the convergence of the rough path integral of the third level path in the θ -variation topology.

Proposition 3.21. Let $\frac{3}{2} < \alpha < 2$, $\frac{2}{3-\alpha} \le q < 4$. Moreover, let $Z_j(x) := (L_t^x, g_j(x))$, and $Z(x) := (L_t^x, g(x))$, where $g_j(\cdot), g(\cdot)$ are both continuous and of bounded q-variation. Suppose $g_j(x) \to g(x)$ as $j \to \infty$ uniformly and the control function $\mathbf{w}_j(x,y)$ of g_j converges to the control function $\mathbf{w}(x,y)$ of g as $j \to \infty$ uniformly in (x,y). Then as $j \to \infty$ such that the geometric rough path $\mathbf{Z}_j(\cdot)$ associated with $Z_j(\cdot)$ converges to the geometric rough path $\mathbf{Z}(\cdot)$ associated with $Z(\cdot)$ a.s. in θ -variation topology as $j \to \infty$. Here, we choose a θ such that $\frac{4}{2h+\alpha-1} < \theta < 4$. In particular, $\int_{-\infty}^{\infty} g_j(x) dL_t^x \to \int_{-\infty}^{\infty} g(x) dL_t^x$ a.s. as $j \to \infty$.

Proof. By the reasoning given above and under the conditions given in the proposition, one can obtain the geometric rough path $\mathbf{Z}_j(\cdot)$ associated with $Z_j(\cdot)$, and also the smooth rough path $\mathbf{Z}_j(m)$. Here the \mathbf{Z}_j is defined as $\mathbf{Z}_j = (1, \mathbf{Z}_j^1, \mathbf{Z}_j^2, \mathbf{Z}_j^3)$ while $\mathbf{Z} = (1, \mathbf{Z}_j^1, \mathbf{Z}_j^2, \mathbf{Z}_j^3)$, similarly we have $\mathbf{Z}_j(m) = (1, \mathbf{Z}_j^1(m), \mathbf{Z}_j^2(m), \mathbf{Z}_j^3(m))$ while $\mathbf{Z}(m) = (1, \mathbf{Z}_j^1(m), \mathbf{Z}_j^2(m), \mathbf{Z}_j^3(m))$. The convergence of $\mathbf{Z}_j(\cdot) \to \mathbf{Z}(\cdot)$ in θ -variation means the convergence of corresponding level path in θ -variation when $g_j(\cdot) \to g(\cdot)$ as $j \to \infty$. We have discussed the convergence of first and second level in Proposition 3.10. By similar argument as in Proposition 3.10, one can show the convergence of the third level path.

Next, we prove that in fact the proposition above is also true for function g being of bounded q-variation $(\frac{2}{3-\alpha} \le q < 4)$, but not being continuous.

Theorem 3.22. Let g(x) be a càdlàg path with bounded q-variation $(\frac{2}{3-\alpha} \le q < 4)$. Then

$$\int_{x'}^{x''} L_t^x dg(x) = \int_{x'}^{\tau_{\delta}(x'')} L_{t,\delta}(y) dg_{\delta}(y).$$

The proof of the Theorem 3.22 is similar to Theorem 3.12. Based on Theorem 3.22 and Proposition 3.21, one can prove the following proposition

Proposition 3.23. Let $\alpha \in (\frac{3}{2},2)$, $\frac{2}{3-\alpha} \leq q < 3$, one can choose θ such that $\frac{4}{2h+\alpha-1} < \theta < 3$. Moreover, let $Z_j(x) := (L_t^x, g_j(x)), Z(x) := (L_t^x, g(x)),$ where $g_j(.), g(.)$ are both of bounded q-variation, and g_j is continuous and g is càdlàg with decomposition $g = g_c + h$, where g_c is the continuous part of g and h is the jump part of g. Suppose $g_j = g_{c_j} + h_j$ with control function \mathbf{w}_{c_j} and \mathbf{w}_{h_j} such that $g_{c_j} \to g_c$ and $\mathbf{w}_{c_j} \to \mathbf{w}_c$ uniformly, h_j satisfying conditions (3.47) in Proposition 3.13. Then

$$\int_{-\infty}^{\infty} g_j(x) dL_t^x \to \int_{-\infty}^{\infty} g(x) dL_t^x \quad a.s. \quad as \quad j \to \infty.$$

Recall ρ as the mollifier and define

$$h_j(x) = \int_0^2 \rho(z)h(x - \frac{z}{i})dz$$

and $h_{j\delta}$ in the same way as G_{δ} , so $h_{j\delta} = h_{j}$ as h_{j} is continuous. Define h_{δ} in the same way as G_{δ} , then

$$h_{\delta j}(y) = \int_0^2 \rho(z) h_{\delta}(y - \frac{z}{j}) dz.$$

Thus by the integration by parts formula and Fubini theorem, we have

$$\begin{split} &\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta j}(y) \\ &= -\int_{-\infty}^{\infty} h_{\delta j}(y) dL_t^{\delta}(y) \\ &= -\int_{-\infty}^{\infty} \int_0^2 \rho(z) h_{\delta}(y - \frac{z}{j}) dz dL_t^{\delta}(y) \\ &= -\int_0^2 \int_{-\infty}^{\infty} h_{\delta}(y - \frac{z}{j}) dL_t^{\delta}(y) \rho(z) dz. \end{split}$$

By Theorem 3.12, we have

$$\int_{-\infty}^{\infty} h_{\delta}(y - \frac{z}{j}) dL_{t}^{\delta}(y) = \int_{-\infty}^{\infty} h(x - \frac{z}{j}) dL_{t}^{x}.$$

Hence,

$$\int_{-\infty}^{\infty} L_t^{\delta}(y) dh_{\delta_j}(y)$$

$$= -\int_0^2 \rho(z) \int_{-\infty}^{\infty} h(x - \frac{z}{j}) dL_t^x dz$$

$$= -\int_{-\infty}^{\infty} \int_0^2 h(x - \frac{z}{j}) \rho(z) dz dL_t^x$$

$$= -\int_{-\infty}^{\infty} h_j(x) dL_t^x$$

$$= \int_{-\infty}^{\infty} L_t^x dh_j(x)$$

$$= \int_{-\infty}^{\infty} L_t^{\delta}(x) dh_{j\delta}(x), \qquad (3.113)$$

The last equality follows from Theorem 3.12. This indicates that condition (3.47) in Proposition 3.13, which is also needed in Proposition 3.23, is satisfied.

The following theorem summarizes the main results of the paper.

Theorem 3.24. Let $X = (X_t)_{t \geq 0}$ be a symmetric α -stable process and $f : \mathbb{R} \to \mathbb{R}$ be absolutely continuous, locally bounded function and has $(\alpha - 1)^{th}$ fractional order derivative $\nabla_{-}^{\alpha - 1} f(x)$ which is locally bounded. Assume $\nabla_{-}^{\alpha-1}f(x)$ is of bounded q-variation, where $1 \leq q < 4$. Then we have the following extended version of Itô's formula

$$f(X_{t}) = f(X_{0}) + \int_{0}^{t} \nabla_{-}f(X_{s})dX_{s}$$

$$+ \int_{0}^{t} \int_{\mathbb{R}} \left(f(X_{s-} + y) - f(X_{s-}) \right) \tilde{N}(dy, ds) - C_{\alpha} \int_{-\infty}^{\infty} \nabla_{-}^{\alpha - 1} f(x) d_{x} L_{t}^{x},$$
(3.114)

where $C_{\alpha} = \frac{\pi^{\frac{1}{2}}\Gamma(1-\frac{2}{\alpha})}{\alpha 2^{\alpha-1}\Gamma(\frac{1+\alpha}{2})}$.

The integral $\int_{-\infty}^{\infty} \nabla_{-}^{\alpha-1} f(x) d_x L_t^x$ is a Lebesgue-Stieltjes integral when q=1, a Young integral when $1 < q < \frac{2}{3-\alpha}$ for $1 < \alpha < 2$ and a rough path integral when $\frac{2}{3-\alpha} \le q < 4$ for $\frac{3}{2} < \alpha < 2$ respectively.

Proof. We have already showed that the integral $\int_{-\infty}^{\infty} \nabla_{-}^{\alpha-1} f(x) d_x L_t^x$ can be defined as a Young integral when $1 < q < \frac{2}{3-\alpha}$ for $1 < \alpha < 2$. Based on the result proved for level 1, level 2, level 3 path and (3.113), as well as applying a standard smoothing argument and taking limit using Proposition 3.23, one can define the integral $\int_{-\infty}^{\infty} \nabla_{-}^{\alpha-1} f(x) d_x L_t^x$ as a rough path integral.
